Sir,

I, ASI Nirmal Kr. Singha of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 20.10.2022 at 20:15 hrs onwards I received a information from my reliable source that 02 nos. of vehicle bearing Reg. No. WB - 73 G 2653 & bearing Reg. No. WB-73 F 8607 loaded with illegal mining river bed materials coming from Tarangubari side without valid documnets. On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S arrival at Tarangubari under Matigara P.S area, I found 02 nos of vehicle bearing Reg. No. WB - 73 G 2653 & bearing Reg. No. WB-73 F 8607 loaded with illegal mining river bed materials going towards Matigara area. Subsequently, I manage to stop both the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded vehicles under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle bearing Reg. No. WB - 73 G 2653 & bearing Reg. No. WB-73 F 8607 under proper section of law and arrange for its investigation.
