With due respect, I am producing herewith 01 (One) arrested accused person namely Bijoy Khatri (53 yrs) S/O Late Rabi Khatri of Flat No-A-1, Rabindra Pally, PS- Matigara, Dist.- Darjeeling presently residening at the house of Tapash Ghosh, D/1, Himachal Bihar, near Passport Office, PS- Matigara, Dist.- Darjeeling under arrest along with seized articles i.e. (i) 01(one) improvised iron made small Fire arms measuring approx approx 24 CM in Length including its 8.2 CM butt & 13.8 CM barrel having trigger, firing pin & firing hammer and marked as Exhibit-"A", (ii)01(One) round of ammunition inscribed as "8 MM" and "KF" on its percussion cap (Which was found inside the exhibit-A) and marked as Exhibit "B" & (iii) One round of ammunition inscribed as "8 MM" and "KF" on its percussion cap(Which was found inside the right side pocket of trouser of Bijoy Khatri ) and marked as Exhibit "C". The ground of arrest duly been communicated with him.

I, SI Uday Charaboty of Matigara PS, SPC do hereby lodge this written complaint against the arrested accused person namely Bijoy Khatri (53 yrs) S/O- Late Rabi Khatri of Flat No-A-1, Rabindra Pally, PS- Matigara, Dist.- Darjeeling presently residening at the house of Tapash Ghosh, D/1, Himachal Bihar, near Passport Office, PS- Matigara, Dist.- Darjeeling. In this regard, I beg to report that today i.e. on 22.10.22 at 14.15 hrs I received a secret information that one peson namely Bijoy Khatri of Hmachal Bihar under PS- Matigara, Dist.- Darjeeling was moving at near Khaprail Bazar under PS- Matigara, Dist.- Darjeeling with one improvised fire arms loaded with live ammunition most probably for committing heinous crime at the locality. Accordingly, I Diarised the information in General diary vide Matigara PS GDE No 1165 dated 22.10.2022 and informed the fact to the officer-in-Charge, Matigara PS. As per kind order and direction myself along with PSI Shekhar Adhikary, ASI Tapan Das, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, C/974 Mintu Sen, CV/155 Sukumar Das all of Matigara PS left for Khaprail Bazar under PS- Matigara, Dist.- Darjeeling with investigation kit vide Matigara PS GDE No 1166 dated 22.10.22. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. At about 14.45 hrs we arrived at Khaprai bazar and after arrival at Khaprail Bazar I requested two independent witneses namely (i) Sahadeb Roy(32), S/O- Dwijendra Natgh Roy of Patharghata, Polashguri, PS- Matigara, Dist- Darjeeling and (ii) Sanjoy Barman(24), S/O- Bidanu Barman of Patharghata, Polashguri, PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. At about 15.15 hrs as identified by the source we noticed that one person was moving Khaprail Bazar infront of mbile shop styled as "Kajal Muskan" but seing the police party he tried to fled away from the spot but we managed to apprehended him. On being asked he disclosed his identity as noted above. As per source information, that he possesed improvised fire arms and ammunition. Hence, immediately I searched the said detained person in presence of above noted witnesses and found 01(one) improvised iron made small Fire arms measuring approx 24 CM in Length including its 8.2 CM butt & 13.8 CM barrel having trigger, firing pin & firing hammer loaded with 01 (one) round of ammunition which the apprehended persons named Bijoy Khatri kept consealed in his waist.On further search another ammunition found from his possession which was kept in the right side pocket of his trouser. On demand failed to produce any valid document in support of possessing the said improvised fire arm and live ammunition.On interrogation he confressed that he possessed the said illegal fire arms for committing heinus crime. Accordingly I seized the abiove noted seized articles as per seizure list in presence of above noted witnesses and duly acknowleged by the apprehended person and marked as Exhibit "A", Exhibit "B" & Exhibit "C" respectively. The search, seizure and label made in between 15.45 hrs to 16.35 hrs on 22.10.22 Subsequently, I arrested him by preparing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Bijoy Khatri (53 yrs) S/O Late Rabi Khatri of Flat No-A-1, Rabindra Pally, PS- Matigara, Dist.- Darjeeling presently residing at the house of Tapash Ghosh, D/1, Himachal Bihar, near Passport Office, PS- Matigara, Dist.- Darjeeling is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Bijoy Khatri (53 yrs) S/O Late Rabi Khatri of Flat No-A-1, Rabindra Pally, PS- Matigara, Dist.- Darjeeling presently residening at the house of Tapash Ghosh, D/1, Himachal Bihar, near Passport Office, PS- Matigara, Dist.- Darjeeling under appropriate section of law and arrange for its investigation.
