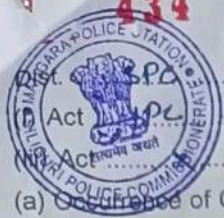

Respected Sir,

With due respect, this is to draw your kind attention the fact that I Ankita Roy resident of Medical More, Dighliote and D/O Kalyani Roy was harassed and physically assaulted by four boys in front of feet Marbel (Service Road) on 22nd October around late evening 10:30 P.M. I was travelling via scooty with my friend Atash Islam, while returning back home we saw four boys ganged against us and started hitting both of us all of a sudden with helmet pushing and pulling to and fro trying to strangulate me. I was trying to inform the police.

They men tried to snatch our bags, mobile phone, scooty key. They even slapped and kicked me on my lower abdomen. I kept on pleading for not harming us, but they threatened until the police arrived at the incident spot.
