Sir,

With due respect, I am producing herewith one arrested accused person namely Ganesh Das (52) S/O Lt. Dilip Das of NJP Railway Hospital More, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 07 (Seven) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
2. 06 (Six) bottles of Kingfisher Strong Beer (each bottle containing 650 ml)

I, SI- Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 17.10.2022 at 22.10 hrs I received a secret source information that one person namely Ganesh Das (52) S/O Lt. Dilip Das of NJP Railway Hospital More, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at NJP Railway Hospital More, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 798 dated 17.10.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Railway Hospital More, PS/ NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.35 hrs we arrived at NJP Railway Hospital More, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 22.55 hrs to 23.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ganesh Das (52) S/O Lt. Dilip Das of NJP Railway Hospital More, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
