Sir,

With due respect, I am producing herewith one arrested accused person namely Sibnath Paul (44) s/o Satish Chandra Paul of Ambikanagar, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 02 (Two) bottle of Haywards 5000 Super strong Beer containing 350 ml. in each bottle.
2. 05 (Five) Bottle of 70 up Country Spirit containing 300 ml in each bottle.
3. 02 (Two) Bottle of Officer-Choice Dulex Whiskey containing 750 ml in each bottle.
4. 03 (Three) Bottle of Officer-Choice Dulex Whiskey containing 375 ml in each bottle.
5. 03 (Three) Bottle of Mc Dowells No.- 01 Luxury Premium Whiskey containing 375 ml in each Bottle.

I, SI- Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 18.10.2022 at 2345 hrs I received a secret source information that one person namely Sibnath Paul (44) s/o Satish Chandra Paul of Ambikanagar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Gate Bazar, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 842 dated 18.10.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Gate Bazar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2355 hrs we arrived at Gate Bazar, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 0035 hrs to 0105 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sushanta Saha (41) s/o Lt. Naren Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
