With due respect, I am producing herewith the arrested accused persons namely (i) Goutam Roy (36) s/o Sudir Roy of Suryasen Colony, Block F, PS-NJP, Dist.- Jalpaiguri (ii) Partha Paul (25) s/o Sanjib Paul of Ambikanagar, PS-NJP, Dist.- Jalpaiguri (iii) Rohit Prasad (21) s/o Uttam Prasad of Ambikanagar, near Chatt Pukur, PS- NJP, Dist.- Jalpaiguri (iv) Partho Kali (40) s/o Tapan Kali of Subash Pally, Ward No.- 17, PS- Siliguri, Dist.- Darjeeling and the following articles under seizure :-

- 1 One sharp cutting Bhojali and Blunt Iron Rod and Small Hammer from the possession of accused (i) Goutam Roy (36) s/o Sudir Roy of Suryasen Colony, Block F, PS-NJP, Dist.- Jalpaiguri
- 2 One iron made Hasua from the possession of accused Partha Paul (25) s/o Sanjib Paul of Ambikanagar, PS-NJP, Dist.- Jalpaiguri
- 3 One sharp cutting knife and Screw Driver, one Torch Light and One Iron Rod measuring 45 Inch from the possession of accused Rohit Prasad (21) s/o Uttam Prasad of Ambikanagar, near Chatt Pukur, PS- NJP, Dist.- Jalpaiguri
- 4 One iron made sabol, One Torch Light & One Bhojali from the possession of accused Partho Kali (40) s/o Tapan Kali of Subash Pally, Ward No.- 17, PS- Siliguri, Dist.- Darjeeling

I, SI Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 20.10.2022 at 00.05 hrs I received a secret source information that a gang of miscreants come to below Mahananda Bridge, Noukaghat under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Noukaghat & Porajhar area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 886 dated 20.10.2022. As per kind order and direction of my superior officer myself along with ASI Sajal Das, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Noukaghat to work out the information in hand. I also informed the fact to night RT Van officer SI Shyamal Dutta Roy of New Jalpaiguri PS, Siliguri Police Commissionerate and directed him to come to Noukaghat to accompany with us during Raid. At about 01.35 hrs on 20.10.2022 we arrived at Noukaghat. After a few time night RT van officer SI Shyamal Dutta Roy of New Jalpaiguri PS, SPC along with force came to Noukaghat and accompany with us. At about 00 55 hrs we found that 10/11 persons assembled in a dark place at below Mahananda Bridge, Noukaghat and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 06 (six) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons I found (One sharp cutting Bhojali and Blunt Iron Rod and Small Hammer from the possession of accused (i) Goutam Roy (36) s/o Sudir Roy of Suryasen Colony, Block F, PS-NJP, Dist.- Jalpaiguri (ii) One iron made Hasua from the possession of accused Partha Paul (25) s/o Sanjib Paul of Ambikanagar, PS-NJP, Dist.- Jalpaiguri (iii) One sharp cutting knife and Screw Driver, one Torch Light and One Iron Rod measuring 45 Inch from the possession of accused Rohit Prasad (21) s/o Uttam Prasad of Ambikanagar, near Chatt Pukur, PS- NJP, Dist.- Jalpaiguri (iv) One iron made sabol, One Torch Light & One Bhojali from the possession of accused Partho Kali (40) s/o Tapan Kali of Subash Pally, Ward No.- 17, PS- Siliguri, Dist.- Darjeeling

During further interrogation they admitted their guilt and disclosed that they are assembled at below Mahanda Bridge and making preparation for committing dacoity at Noukaghat area. Accordingly, I seized the above noted weapon of offence under proper seizure list and arrested the above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure, label and arrest made in between 02.15 hrs and 03.05 hrs on 20.10.2022
