Sir,

In producing herewith one accused person named Raju Oraon (32) S/O- late Hindu Oraon of Baghajatin Colony near Baghajatin High School, PS- Pradhannagar Dist- Darjeeling under arrest along with following articles under proper seizure.

- (i) Twelve (12) bottles of Kingfisher Strong premium beer each bottle containing 650 ml. bolted united Breweries Ltd., vital Mallya road , Kalyani, West Bengal . Out of which one bottle has been taken as sample for examination .

I, SI Sibdhan Karmakar of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Raju Oraon (32) S/O- late Hindu Oraon of Baghajatin Colony near Baghajatin High School, PS- Pradhannagar Dist- Darjeeling to the effect that today on 21.10.2022 at 19:30 hrs received a source information that one person is selling liquor in his house situated at Baghajatin Colony near Baghajatin High School under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to you and as per your kind direction I along with ASI Ashit Singha,, CV-992 Jagadish Biswas CV/646 Baban Das and CV-242 Rakesh Monger all of Pradhannagar P.S had been to Baghajatin Colony near Baghajatin High School under Pradhan Nagar PS to verify the veracity of the information . This refers to Pradhannagar P.S. GDE no.1177, Dt. 21.10.22. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his house. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Thereafter on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house . Further being searched the above noted seized articles were found in the said house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Raju Oraon (32) S/O- late Hindu Oraon of Baghajatin Colony near Baghajatin High School, PS- Pradhannagar Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:05 hrs to 20.30 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Raju Oraon (32) S/O- late Hindu Oraon of Baghajatin Colony near Baghajatin High School, PS- Pradhannagar Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
