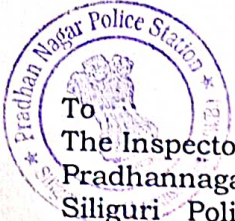

Sir,

With due respect and humble submission, in producing herewith one accused namely Debabrata Mohanto (36) S/O Sri Birendra Nath Mohanto of Samarnagar ,P.S-Pradhannagar , Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 20(Twenty) Pouch Packet of Officer Choice ,Deluxe whiskey ,each containing 180 ML,each MRP 130/-
- ii) 14(Fourteen) bottles of Kingfisher Strong BEER each bottle containing 650 ml. ,each MRP 120/-
- iii) 08(eight) Plastic bottles of Old monk ,Matured XXX Premium Rum ,each bottles containing 180 ML ,each MRP 140/-
- iv) 06(Six) bottle of Sterling Reserve B7,Classique blended Whiskey ,each bottles containing 180 ML,each MRP .180/-
- v) 04 (four) Bottles of Mc Dowells No 1 superior whiskey ,each containing 180 ML, each MRP 160/-
- vi) 07(seven) bottles of Royal Stag , blended Whiskey, each containing 180 ml ,each MRP 200/-

I ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 21.10.22 in course spl mobile van duty at PS area with force CV/645 Pankaj Gupta ,CV/242 Rakesh Monger vide PDN PS GDE NO 1177 dtd.21.10.22 at 21.35 hrs ,I received an information that the one person namely Debabrata Mohanto is storing and selling liquor illegally in his Hotel style as Mohanto Hotel at Regulated market gate no.1 under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his shop recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21.55 hrs to 22.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Debabrata Mohanto (36) S/O Sri Birendra Nath Mohanto of Samarnagar ,P.S-Pradhannagar , Dist. Darjeeling and arrange for its investigation.
