Recently on 21/10/2022 few criminals (15-16) numbers came to our Dagapur Complex with 2 numbers of Bolero viechles at 5:00 PM and entered in our premises and broke the lock of the gate of Washi Akhtar Shah of Kurseong who occupied 4 kathas of land illegally on the basis of forged documents.

This is the 4th time the criminals have broke our locks of the gate in our Dagapur Complex on the same gate. We came to know that the main criminals are Shri Rajesh Rajak, Rajib Rajak both are the son of Shri Ram sundar Rajak and Smt. Sarita Rajak wife of Shri Rajesh Rajak, all of them residents of Kadamtala, Champasari, North Mallaguri, Ward number 46, PO & PS Pradhan Nagar, Siliguri 734003.
