I, **SRI DEO NATH SAH**, Son of Bhagwan Sah, resident of Rampur, Post Office and Police Station: Marhaura, District: Saran (Chapra), Bihar, PIN – 841311, Bihar and presently residing at Prafulla Nagar, Champasari, Post Office and Police Station: Pradhan Nagar, District: Darjeeling, in the State of West Bengal, PIN – 734003 am the lawful constituted attorney of Smt. Ananti Devi @ Anandi Debi of 1392/2, Jhalupara, Shillong, Post Office & Police Station - Jhalupara, District - East Khasi Hills, in the State of Meghalaya, Pin 793002 is the sole and absolute owner of land measuring 3 Kathas and 8 Chhataks, appertaining to and forming part of Plot No. 140 corresponding to L.R. Plot Nos. 5074 and 5101, Khatian No. 25 corresponding to L.R. Khatian No. 2709, situated within Mouza–Mandalaguri, Parghana - Patharghata, J.L. No. 107, Police Station – Pradhan Nagar, Dist.
