Sir,

With due respect, I am producing herewith one accused person namely ManikDey (62) S/O- Late Krishna Chandra Dey of 45/7 Baghajatin colony ,PS- PradhannagarDist. Darjeeling under arrest along with following articles under proper seizure

- i) 175 (one hundred and seventy five) packets of "JUGMUG" StandardChocolete Electricflash soundfire Crackers, each packets containing 12 pices each Mrp.110 / .
- ii) 115 (one hundred and fifteen) packets of RHINO Power chocolate Sound fire cracker each packets containing 10 pcs. Manufactured by SS Enterprise, Kolkata.
- iii) 05(five) packets of 1000 walasoundfire cracker manufactured by R.P. Fire Works,Sivakasi each packet MRP. 765/
- iv) 110 (one hundred and ten) packets of KING COBRA premium Chorsasound fire crackers each packetcontaining 28 pices manufactured by Sri Balaji FireworksIndustries, Sivakasi .
- v) 10(ten) packets of RONGOLI, Jai Pyrote technics, Sivakasi sound fire crackers each packet 25 Shots each packet MRP.1500/.
- vi) 05(five) packets of 600 LAR Sound firecrackers manufactured by sriBala Krishna Fire Works, 898, Kamakroad, Siva Kasi.
- vii) 06(six) packets of 300 wala celebration sound fire crackers manufactured by PrabhuramFireworks Factory, Siva Kasi.
- viii) 02(two) packets of Balaji Pujo MAX 120 multi colour shoots manufactured by Sree Balaji Pyrotechnics,Sivakasi.
- ix) 03(three) packets of Glitter 100 shoots sound fire crackers.
- x) 04 (four) packets of 15 colour shoots supreme sound fire crackers manufactured by Fireworks Factory, Siva Kasi.
- xi) 01(one) packet of Nayagi Whizzling 25 sound fire crackers manufactured by Nayagi Fireworks Industries,Sivakasi.

In this regard I, ASI Manoj Kumar Roy of Pradhannagar P.S. under Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person to that effect that today on 22.10.22 while performing Special Mobile van duty in and around Champasari More area under Pradhannagar PS Jurisdiction Vide Pradhannagar PS PS. GDE No.1244 Dt. 22.10.22, During patrolling I received source information that one Manik Dey has stored huge quantity Fire Cracker in his shop name and style as "Ritika" illegally at Champasari More . Accordingly, I informed the matter to you and as per your direction I along with force C/762 MajibulRahaman, CV/128 Ajay Kr Sahani, CV/223 Swapan Kr Chettri , CV-645 Pankaj Gupta conducted raid in the same shop, and apprehended the owner of Shop named Manik Dey(62) S/O- Late Krishna Chandra Dey of 45/7 Baghajatin colony ,PS- Pradhannagar Dist. Darjeeling. On searching his shop found huge quantities of fire crackers stored in his shop and selling the same to the local people illegally for his wrongful gain disobeying the direction of the Hon'ble High Court Kolkata vide Order date 11.10.22 C/W WPA (P)no.292/2021 with IA No. CAN 1 of 2022 and storing the



same negligently which may cause endanger to human life or property and the said articles are also combustible in nature. On demand he failed to produce any valid license in favor of recovered fire crackers. Accordingly, I seized those firecrackers and after preparing proper seizure list duly signed by the witness. The seizure was made in between 21.25 hrs to 22.50 hrs. Thereafter I arrested the above noted accused person after observing all sorts arrest rules informing the ground of arrest.

I therefore pray before you that a specific case may kindly be initiated against accused named ManikDey(62) S/O- Late Krishna Chandra Dey of 45/7 Baghajatin colony ,PS- Pradhannagar Dist. Darjeeling under proper section of law.
