With due respect and humble submission
I Neha Sah wife of Sashi Sah would like to state
that presently I am residing at Jaigaon at my father's
house at Bhagat Singh Nagar. On Dated 30 Nov, 2013, I got
married to Sashi Sah, son of Jagdish Sah and Sushila Sah
resident of Bonarhat, Hatkhola Bazar, Dist: Jalpaiguri. After
few days of marriage my in-laws and my husband started
inflicting physical and mental torcher upon me on petty issues.
On year 2016 I get pregnant but as a result of their
physical and mental torcher I suffered from miscarriage.
On this incident we did verbal complain in Jaigaon P.S.
and then my sister-in-law and her husband got arrested.
But instead their physical and mental torcher increased
extremely on me and as a result I sustained three
more miscarriages on year 2017, 2018, 2019. Lastly, with
the grace of god, on 17 Dec 2021, I get a baby boy
delivered at Siliguri, residential house located at
Jeevan Mandir road; but my husband and my in-laws
were unhappy by this good news and their physical
and mental torcher on me and my baby increased day
by day which was so unbearable for that reason
I lodged a complain against my husband and
in-laws which is registered at Bhaktinagar P.S.

Siliguri as case No. 749/2022, Dated on 12-07-2022.

After few days of this case my husband & my in-laws get bail and they started pressurizing me to give divorce to my husband and withdraw the case. Since then I get calls from different unknown numbers to withdraw the cases or else they will harper me and my son.

Today at around 7:51 pm I received a call from a unknown number (+977982-8039545 / +977982-8039545)

explaining herself as my husband's new wife, named Pooja Chettri, and she used abusive words for me and my son, and threatened me and my son with dire consequences.

And after sometime, me and my 10 months old baby boy were crossing savok road, we were in a auto-rickshaw, my husband suddenly came in byke No. 0499 and tried to harm me and my baby and used abusive words for us, he threatened us with dire consequences but anyhow I escaped / fled from the situation and reached bhaktinagar P.S.

Under these circumstances, I pray before you to take necessary action against the above mentioned accused person
