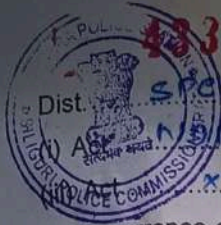

Sir,

With due respect I, SI Md Sanaullah of Matigara PS, Siliguri Police Commissionerate do hereby lodge this written complaint against accused person named Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) S/O Bharat Mandal of Balufara, PO- Sahabajpur, PS- Kaliachak, Dist.-Malda who was arrested on 13.10.22 in C/W Matigara PS Case No 1047/22 dated 09.10.22 U/S 21(C) NDPS Act and produce the following articles under seizure i.e :-

(i) One orange colored carry bag containing 276 grams of said to be brown sugar which was kept inside a transparent plastic zip lock pouch and is marked as Exhibit- "A".

(ii) One transparent plastic zip lock pouch containing 20 grams of said to be brown sugar which was taken from Exhibit- A as sample for examination and is marked as Exhibit- "A-1".

The brief fact of the above mentioned case is that on 09.10.22 PSI Shekhar Adhikary of Matigara PS lodged a written complaint before the O/C, Matigara PS against 06 (six) arrested accused namely (1) Pushpa Mandal (40) W/O- Raju Sarkar of Alsia Bazaar, near Sadhan More, PS- Matigara, District- Darjeeling, (2) Aduri Bibi (40) W/O- Babu Sk of Ruidaha, PO & PS- Kishanganj, Bihar, (Not verified) (3) Binod Prasad (55) S/O- Late Jangilal Prasad of Batasi, PS- Khoribari, Dist- Darjeeling, (4) Dipankar Mandal (28) S/O- Jatin Mandal of Alsia Bazaar, near Sadhan More, PS Matigara, (5) Bharat Mandal @ Tablet (26) S/O- Late Sachin Mandal of Kuthipara, PO- Dosatabighi, PS- Kaliachak, District- Malda, (Not verified) and (6) Raju Sarkar (42), S/O- Late Somen Sarkar of Alsia Bazaar, near Sadhan More, PS- Matigara, District- Darjeeling and others two accused persons namely (1) Sk Jaher Kana of jaipur, PS- Baisnabnagar, Dist.- Malda and (2)Md Tamanna of Gowala Patty, PS- Siliguri, Dist.- Darjeeling to the effect that on 09.10.22 PSI Shekhar Adhikary had recovered and seized total 1.579 Kgs of said to be Brown sugar form the possession of accused (1) Pushpa Mandal (40) W/O- Raju Sarkar of Alsia Bazaar, near Sadhan More, PS- Matigara, District- Darjeeling, (2) Aduri Bibi (40) W/O- Babu Sk of Ruidaha, PO & PS- Kishanganj, Bihar, (Not verified) (3) Binod Prasad (55) S/O- Late Jangilal Prasad of Batasi, PS- Khoribari, Dist- Darjeeling, (4) Dipankar Mandal (28) S/O- Jatin Mandal of Alsia Bazaar, near Sadhan More, PS Matigara, (5)Bharat Mandal @ Tablet (26) S/O- Late Sachin Mandal of Kuthipara, PO- Dosatabighi, PS- Kaliachak, District- Malda, (Not verified) and (6) Raju Sarkar (42), S/O- Late Somen Sarkar of Alsia Bazaar, near Sadhan More, PS- Matigara, District- Darjeeling. Over this Matigara PS case No 1047/22 dated 09.10.22 U/S 21(C) NDPS Act was registered and being endorsed myself SI Md Sanaullah of Matigara PS took up the investigation of the case. During investigation on 10.10.2022 I forwarded all the above noted arrested 06 (six) accused persons before the Ld. Court and taken for 07(seven) days police remand. During remand period on 13.10.22 as per leading statement of the remand accused, I arrested FIR named accused Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) S/O Bharat Mandal of Balufara, PO- Sahabajpur, PS- Kaliachak, Dist.- Malda and on 14.10.22 I forwarded him before Ld. court and taken for 10 (ten) days police remand.

During remand period, he was subjected to thorough interrogation and the accused on 22.10.22 the remand accused Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) confessed that on 07.10.22 he had come to Matigara and had brought along with him brown sugar (approx 275 grms) after having made contact with his designated customer namely Md Tamanna. As per the requirement of Md Tamanna, he had kept approx 275 grams of Brown Sugar in the bathroom of the under constructed bathroom of Md Tamanna. Accordingly, I recorded his statement U/S 161 Cr.P.C. in a separate sheet of paper and informed the fact to the O/C, Matigara PS, SPC who directed me to recover the brown sugar from the residence to Md. Tamanna after observing all the formalities as per norms of NDPS Act.

Accordingly, as per order I informed the fact to Shri Moksedur Rahaman, Asstt Commissioner of Police, Siliguri Police Commissionerate, detailed as Spl. Executive Magistrate for the day of Siliguri

Police Commissionerate, and requested him to come at Matigara PS for the said purpose. At about 15:35 hrs Shri Moksedur Rahaman, Asstt. Commissioner of Police, Siliguri Police Commissionerate detailed as Spl. Executive Magistrate for the day of Siliguri Police Commissionerate arrived at Matigara PS. At 15:54 hrs, myself along with ASI Tapan Das, C/1053 Paresh Rava, C/374 Debraj Biswas, C/974 Mintu Sen all of Matigara PS the with investigation kit and Shri Moksedur Rahaman, Asstt Commissioner of Police, Siliguri Police Commissionerate detailed as Spl Executive Magistrate for the day of Siliguri Police Commissionerate and videographer namely Santosh Mohanto (28) S/O- Bisheshwar Mohanto of Sishabari, PO- New Rangia, PS- Matigara, Dist- Darjeeling left for Binoy Krishna Pally, Tumba Jote under Matigara PS with the remand accused Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) S/O Bharat Mandal of Balufara, PO- Sahabajpur, PS- Kaliachak, Dist.-Malda to follow up the confession made by the accused vide Matigara PS GDE No 1167 dated 22.10.22 and MCC No 633/22 dated 22.10.22. On the way to Binoy Krishna Pally, Tumba Jote, I requested two independent witnesses namely (i) Md Azad (40 yrs) S/O Md Meheebub and (ii) Parimal Sarkar (43 yrs) S/O Late Brajen Sarkar both of Tumba Jote, Beldangi, PS- Matigara, Dist.- Darjeeling to accompany us and remain present during the time of search and seizure to which they agreed.

The under construction premises of Md Tamanna was identified by the PC accused at Binoy Krishna Pally, Tumba Jote under PS- Matigara, Dist.- Darjeeling, where we reached at 16:25 hrs. The premises had two blocks which were under construction and had separate bathroom and toilets within the premises and has concrete boundary with two iron gates. I offered the said remand accused person and the independent witnesses to search our Police Party as per provisions but they denied to search our police party. The remand accused Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) S/O Bharat Mandal of Balufara, PO- Sahabajpur, PS- Kaliachak, Dist.-Malda then led us to the under construction bathroom within the premises and brought out one orange coloured carry bag inside which there was a transparent plastic zip lock pouch containing 276 grams of said to be brown sugar. The accused Jagadish Mandal @ Sk Jahir Kana @ Jagga stated that this was the brown sugar brought by him and he was instructed by Md Tamanna to keep it in his under construction bathroom. Accordingly, I seized the recovered orange coloured carry bag containing 276 grams of said to be brown sugar which was kept inside a transparent plastic zip lock pouch under proper seizure list in presence of witnesses and under the supervision of Shri Moksedur Rahaman, Asstt. Commissioner of Police, Siliguri Police Commissionerate detailed as Spl. Executive Magistrate, Siliguri Police Commissionerate and marked as Exhibit- "A".

The whole process of seizure and labeling was made from 16:45 hours to 17:25 hours and the entire process was video graphed by the above noted video-grapher. Out of the seized contraband 'brown sugar' marked as Exhibit A, 20 (twenty) gms of contraband brown sugar was taken from Exhibits-A as sample for examination and is marked as exhibit "A-1".

Under the above circumstances, I pray that a specific case under proper section of law may kindly be registered against accused Jagadish Mandal @ Sk Jahir Kana @ Jagga (39 yrs) S/O Bharat Mandal of Balufara, PO- Sahabajpur, PS- Kaliachak, Dist.-Malda and Md. Tamanna, PS-Siliguri to arrange for its investigation.
