I Smt Sunaina Mahato w/o Lt Jagadith Mahato R/o Nevadita Road, near Gramin Bank P.O. & P.S. Pradhannagar would like to inform you for your kind information and necessary action. That one Poonam Kumari Mahato w/o Sunil Kr Mahato R/o Nevadita road, near Gramin Bank Police Station Pradhannagar, who is my daughter-in-law have started to quarrel with me and my younger son with slight issue, inspite of the best we are living separately from her in different rooms of our house. That today at about 4:30 P.M. said Poonam Kumari Mahato has wilfully broken the C.C.T.V camera in the front of our room and when my younger son Sushil Kr Mahato protest her illegal act of said Poonam Mahato she started to assault my son Sushil Kr Mahato physically and when Sushil tried to defend himself from her, she hit my son Sushil with batam on his forehead and my son Sushil have sustained grave injury on his forehead and fallen on the ground and started to vomit at this I came to rescue my son from her clutch and then she started to assault me physically with the batam and when I raise alarm said Poonam Mahato fled from the spot and entered in her room threatening me with dire consequences. I admitted my son in Siliguri hospital for treatment. So I humbly request you to take proper legal action as per law against Poonam Mahato under appropriate
