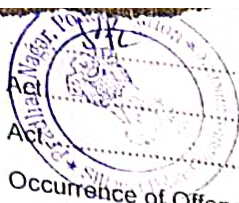

Sir,

In producing herewith one accused person namely Guddu Kumar (19), S/O- Baidyanath Ray of Nauranga, Basantipur Bangla, PS Amnor, Dist Chapra(Saran), Bihar under arrest and following seized articles under seizure -

- 1) 06 (Six) Packets of BULLET BOMB FLASH SPECIAL by Sri Krishna Fireworks Factory (P) Ltd. (each packet containing 10 pieces),

I, PSI- Bhiswadeb Barman of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused person namey Guddu Kumar (19) to the effect that today on 24.10.2022 at 20.10 hrs when performing my van duty, I found that one Guddu Kumar (19), S/O- Baidyanath Ray of Nauranga, Basantipur Bangla, PS Amnor, Dist Chapra(Saran), Bihar was bursting banned firecrackers i.e. Non Green Fire Crackers at champasari bazar by violating the Order passed by the honourable Supreme Court of India also Govt. rules and norms and violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Pradhan Nagar PS GDE No- 1367 dated 24.10.2022. Accordingly, as per your kind order I along with force all of Pradhan PS, SPC tried to restrain him for obstructing the Govt. rules.

Subsequently I apprehended the above mentioned person for violating Govt. Orders. Moreover, the above noted fire crackers were bursted without any precautionary and safety measures and thus, violated the section 286 of Indian Penal Code. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused person namely Guddu Kumar. The whole process of seizure was made between 20.25 hrs to 21.00 hrs in presence of one independence witness. Subsequently, I arrested the above noted accused person namely Guddu Kumar observing all the formalities and informing the ground of his arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person Guddu Kumar (19), S/O- Baidyanath Ray of Nauranga, Basantipur Bangla, PS Amnor, Dist Chapra(Saran), Bihar under proper section of law and arrange for its investigation.
