Sir,

In producing herewith one arrested accused person namely CHITTARANJAN DEBNATH-55YRS S/O LT KHITISH DEBNATH OF PARESHNAGER WARD NO-44, PS BHAKTINAGAR DIST JALPAIGURI along with following seized articles viz:

1. One packet of Burima colour changing super light each packet contained with 10 pieces
2. One box of ground chakkar fire crackers each box contained with 24pieces
3. Two boxes of X mass tree manufactured by Five works industries Sivakashi each box contained with 05 pcs
4. 38 Boxes of Angry birds, POPPOP magic wrinkle sound fire crackers each box contained with 50 pieces and 48 boxes are kept in a box
5. Five packets of flower pots big each packet contained with 10 pieces
6. Thirty packets of Raj Kumari Electric sparklers fire crackers each packet contained with 10 pcs
7. 40 boxes of original colours of POP POP magic wrinkle sound each boxes contained with 50 pieces and 40 boxes are kept in a box
8. 29 packets of Burima sonar chand, electric sparklers fire crackers each packet contained with 10 pieces
9. 17 packets of Burima sonar chand electric Fuljhorl each packet contained with 10 pieces
- 10.02 packets of Burima chakmuki rong moshala each packet contained with 10 pieces
11. Three packets of Riya Ground chakkar (Big) each packet contained with 23 pieces
12. One packet of golden Torches special (JUGMUG) fire crackers each packet containing 10 pieces
- 13.05 (Five) packets of Puja chutput firecrackers manufactured by Puja Traders each packet contained with 10 pieces.
14. 10 packets of Burima Diwali Electric sparklers fire crackers each packet contained with 10 pieces
- 15.05 packets Burima flower pot anar special each packet contained with 10 pieces
- 16.03 packets of puja jambo 10 chakkar each packet contained with 10 pieces
17. Five pieces of Burima colour Koti (Red & Green) which was kept in a box.

I beg to report that I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 22.10.22 at 16.05hrs received secret source information that one person stored and selling huge quantity of fire crackers at his Grocery shop style as Maa Laxmi stationery at Ektiashal Bazar. Diarized the information in GD vide Bhaktinagar PS GDE no-1056 dated 22.10.22 and as per your kind instruction myself along with ASI Dipak Karmakar, Const/1431 Dilip Barman, CVF/014 Labonyamoy Barman, CVF/614 Sumit Kumar Roy left for Ektiashal Bazar to work out the information.

At about 16.40 hrs we reached at Ektiashal Bazar, sometimes after, being identified by the source our police party held raid in the shop of Chattaranjan Debnath and recovered the above noted articles from his shop. On demand he could not produce any valid documents/license in support of said fire crackers and also stated that he was selling the band fire crackers in his shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by them and accused person

from the possession of Ektiashal Bazar and arrested him u/s 41 Cr.pc. (The seizure was made in between 17.10hrs to 19.15hrs)


