Sir,

In producing herewith one accused person namely Bikash Mandal (28) S/O- Lt Jadu Mandal of Shriniwaspur, P.O- Nowada, P.S- Kaliachak, Dist- Malda not verified in custody and the following property under seizure along with seizure list:-

- i. One transparent plastic Packet contains 1365 (One thousand three hundred sixty five) Grams said to be Brown Sugar and Marked as exhibit-"A"
- ii. 10 (ten) grams said to be Brown Sugar taken as sample from Exhibit-A and marked as Exhibit A-1.
- iii. One Samsung Mobile phone Black Colour having Sim No- 7872195086. IMEI No 354739893102256 and marked as Exhibit-B
- iv. One multi Colour Nylon Bag in which Seized article (Sl.No. i) is kept inside the bag

I, SI Rantu Haldar S/O- Manaranjan Haldar of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 23.10.2022 at 13.15 hrs received a secret source information that one person having possession of huge quantity of Brown Sugar in his possession without valid documents and selling to the drug addicted young boys and school /college going students at Prakash nagar more under PS- Bhaktinagar. Accordingly the information was diarized vide BKN PS/SPC GDE No. 1097 Dtd. 23.10.2022 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with SI Sajal Roy, SI Srimanta Chatterjee, ASI Dipak Karmakar, C/1431 Dilip Barman, CV/014 Labanyamay Barman all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-1940/22 Dt. 23.10.2022 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 1098 Dated. 23.10.2022. At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 13.35 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Suraj Sha (22) S/O- Raj Kumar Sha of Shastrinagar, Trianga more, W.No -41, P.S- Bhaktinagar, Dist- Jalpaiguri, and (ii) Goutam Sharma (25) S/O- Binod Sharma of Durganagar, near Kali Mandir, W.no-40, P.S- Bhaktinagar, Dist- Jalpaiguri, also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 13.55 hrs as shown and identified by the source, we found one person was standing in side of the prakash nagar more, NH-31 with one nylon bag and we detained the above noted person along with above noted articles which was kept in his right hand inside the nylon bag. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he is carrying and possessing "Brown Sugar" with him. Then I asked him whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search

by the police party. Then I sent ASI Dipak Karmakar with a written requisition to ACP West Office to bring special Executive Magistrate for conducting search and seizure. At 14.45 hrs ASI Dipak Karmakar returned at the spot with Special executive magistrate Shree Manish Yadav ACP/SPC (West zone) arrived at the spot. I disclosed the identity of Shree Manish Yadav ACP/SPC (West zone) to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision Shree Manish Yadav ACP/SPC (West zone) and in presence of him and independent witnesses I conducted search of the above apprehended person keeping strict regard and found the articles as per seizure list in a multi colour nylon bag which was possessing/carrying by the apprehend person. On being asked he further confessed in presence of Special executive magistrate and other witnesses that he procured the Brown Sugar clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business for last two years and selling the same to the adjacent area of Siliguri, NJP and Bhaktinagar with the help of his associates namely (1)Lusi Khatun C/O- Md. Masrekul Haque of Sadharitola, Sahabazpur, P.S- Kaliachak, Dist-Malda and (2)Pratima Sarkar Das C/O- Biltu Das of Bujrul Bandhail, P.S- Gazole, Dist- Malda. On examination of the alleged apprehended person noted above regarding any documents for carrying/possessing of said Brown Sugar he failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Manish Yadav ACP/SPC (West zone) I weighted the transparent packet with weighing instrument of Bhaktinagar PS/SPC and found that total weight of recovered packet of Brown Sugar including Plastic Pouch having weight 1365(One thousand three hundred sixty five) Grams. Then I seized the articles under proper seizure list and Label under the supervision of Shree Manish Yadav ACP/SPC in presence of witnesses duly signed by them as well as the accused person and marked the seized exhibits as noted above.

The seizure and label was made between 14.55 hrs to 15.45 hrs. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing Brown Sugar without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Bikash Mandal (28) S/O- Lt Jadu Mandal of Shriniwaspur, P.O- Nowada, P.S- Kaliachak, Dist- Malda and arrange for its investigation.
