Sir,
In producing herewith one arrested accused person namely Dilip Das (49), S/O Sunil Das of Chota Sal Kumar PS Falakata Dist Alipurduar, P/A-Niranjan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri along with following 12(Twelve) Kgs of seized fire Crackers.

- i. 05 Packets Rhino Power Chocolate, containing 10 Pcs each
- ii. 20 Packets of Golden King Cobra Electric Crackers., containing 28 Pcs each
- iii. 13 Packets Rhino Champion Chocolate, containing 10 Pcs each
- iv. 05 Packets Chut Putu, Containing 10 pices each.
- v. 05 Packet Jugrugh Chocolate, containing 12 Pcs each

I, ASI Prahlad Singha of Ashighar OP under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the above noted accused person to that effect that today i.e 23.10.2022 while performing evening mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no. 661 dated 23.10.2022 at that time received a secret source information to the effect that two or three shop owners are selling fire crackers illegally situated at the Estern Bypass Near Dhakeshwari Mandir. Accordingly I informed the matter to O/C Ashighar OP and as per his direction I along with my force left for Estern Bypass Near Dhakeshwari Mandir at 19.45 hrs to conduct raid at Estern Bypass Near Dhakeshawri Mandir and as shown by the source I along with my force held raid at the Road side shop of Dilip Das (49), S/O Sunil Das of Chota Sal Kumar PS Falakata Dist Alipurduar, P/A-Niranjan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri and found selling fire crackers in his road side shop situated at Estern bypass Near Dhakeshwari Mandir illegally, on search found huge quantities of illegal firecrackers stored in his shop and selling the same to the local people illegally. I apprehended him in presence of witnesses and demanded him to produced valid papers or license in support of possessing and selling the huge quantities of fire crackers but he failed to produce any documents in support of above noted firecrackers. On further interrogation, he confessed that he had selling the fire crackers locality for his wrongful gain and hence endangered the life of common people. I accordingly, seized the above firecrackers in presence of witnesses and after preparing proper seizure list duly signed by the witnesses and accused and arrested him after preparing proper Memo of Arrest. The whole process of raid, seizure and arrest took place in between 20.25 hrs. to 20:55 hrs on 23.10.2022

It therefore pray before you that a specific case may kindly be initiated against arrested accused Dilip Das (49), S/O Sunil Das of Chota Sal Kumar PS Falakata Dist Alipurduar, P/A-Niranjan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri under proper section of law and arrange for its investigation
