With due respect, I am producing herewith five arrested accused persons namely 1) Biswanath Sutradahr (41yrs) S/O- Paresh Sutradhar of Hatiadanga near Sahudangi, PS- Bhaktinagar, Dist- Jalpaiguri 2) Bura Dutta (44 yrs) S/O- Lt. Adhir Dutta of Ashok Nagar, PS- Bhaktinagar, Dist- Jalpaiguri, 3) Bishal Paswan (23yrs) S/O- Basista Paswan of Rabindra Nagar, Natun Para, W/No- 21, PS- Siliguri, Dist- Darjeeling 4) Koushik Barman (18yrs) S/O- Sushil Barman of Rabindara Nagar, Natunpara, W/No-21 PS- Siliguri, Dist-Darjeeling, 5) Santosh Barman (19 yrs) S/O- Sushil Barman of Nagar, Natunpara, W/No-21 PS- Siliguri, Dist-Darjeeling

I ASI Debasish Das of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on 24-10-2022 at 21:45 hrs while performing Plain Cloth duty at PS Jurisdiction receive a source information that some persons has been using and bursting banned fire crackers at S.F.Road under Siliguri PS. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S vide Siliguri P.S GDE no- 1311 Dated: 24.10.2022 myself along with ASI Subir Sen, ASI siben Sarkar, CV/283 Prasenjit Dey and CV/622 Ramanath Barman left to work out the information and on being identified by the source apprehended the above noted persons enjoying Diwali celebrations with lighting illegal and banned Fire-crackers at S.F Road under Siliguri PS, violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area.

On being asked they admitted thier guilt of using and bursting of banned fire crackers at locality and also violated the govt order which they were aware that any accident can took place due to negligent act of the accused persons that may cause loss of life and property of the area. The Govt. banned Fire -crackers were without any precautionary and safety measure. Accordingly, I arrested the above noted accused persons U/S 41 Cr.P.C.

Hence, I pray before you that a specific case may kindly be started against the arrested accused persons namely Biswanath Sutradahr (41yrs) S/O- Paresh Sutradhar of Hatiadanga near Sahudangi, PS- Bhaktinagar, Dist- Jalpaiguri 2) Bura Dutta (44 yrs) S/O- Lt. Adhir Dutta of Ashok Nagar, PS- Bhaktinagar, Dist- Jalpaiguri, 3) Bishal Paswan (23 yrs) S/O- Basista Paswan of Rabindra Nagar, Natun Para, W/No- 21, PS- Siliguri, Dist- Darjeeling 4) Koushik Barman (18yrs) S/O- Sushil Barman of Rabindara Nagar, Natunpara, W/No-21 PS- Siliguri, Dist-Darjeeling, 5) Santosh Barman (19 yrs) S/O- Sushil Barman of Nagar, Natunpara, W/No-21 PS- Siliguri, Dist-Darjeeling under proper section of law and arrange for its investigation.


