With due respect, I am producing herewith five(05) arrested persons, namely 1) Rakesh Saha (18yrs) S/o- Ram Prasad Saha of Subashpally, Durgadas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling, 2) Ashok Roy (40yrs) S/o- Abodh Lal Roy of Subashpally, Hatimore, W/no- 20, PS- Siliguri, Dist- Darjeeling, 3) Sanjay srkar (35yrs) S/o- Sapan Sarkar of Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling and 4) Mantu Dome (31yrs) S/o- Parichan Dome of Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling and 5) Khokan Biswas (28) S/o- Lt. Sunil Biswas Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling.

I SI Rajiv Subba of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on 24-10-2022 at 22:40 hrs while performing Special Van duty at PS Jurisdiction receive a source information that some persons has been using and bursting banned fire crackers at Subashpally under Siliguri PS. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S vide Siliguri P.S GDE no- 1320 Dated: 24.10.2022 myself along with PSI Biswajit Sarkar, C/1406 Biman Birman, C/1409 Ananta Roy, C/1404 Ujjal Singha left to work out the information and on being identified by the source apprehended the above noted persons enjoying Diwali celebrations with lighting illegal and banned Fire-crackers at Subashpally under Siliguri PS, violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area.

On being asked they admitted thier guilt of using and bursting of banned fire crackers at locality and also violated the govt order which they were aware of that any accident can took place due to negligent act of the accused persons that may cause loss of life and property of the area. The Govt. banned Fire -crackers were without any precautionary and safety measure. Accordingly, I arrested the above noted accused persons U/S 41 Cr.P.C.

Hence, I pray before you that a specific case may kindly be started against the arrested accused person namely Rakesh Saha (18yrs) S/o- Ram Prasad Saha of Subashpally, Durgadas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling, 2) Ashok Roy (40yrs) S/o- Abodh Lal Roy of Subashpally, Hatimore, W/no- 20, PS- Siliguri, Dist- Darjeeling, 3) Sanjay srkar (35yrs) S/o- Sapan Sarkar of Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling and 4) Mantu Dome (31yrs) S/o- Parichan Dome of Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling and 5) Khokan Biswas (28) S/o- Lt. Sunil Biswas Subashpally, Lichu Bagan, W/no- 18, PS- Siliguri, Dist- Darjeeling, under proper section of law and arrange for its investigation.
