Sir,

In producing herewith one accused person namely Ranjan Das(42) S/O Lt Devan Das of Baghajatin colony, P.S: Pradhanagar, Siliguri , Dist: Darjeeling under arrest and following seized articles under seizure -

1. 06 (six) Packets (Krishna Cracker) 6 Pecs Each packets 6X6 = 36 Pcs

I, SI Pratap Basak of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused person namely Ranjan Das (42) to the effect that on 24.10.2022 at 23.15 hrs when I was performing my van duty, I found that the arrested person Rabjan Das was bursting band firecrackers at Gurung Busty Bazar by violating the government order and direction of Hon'ble High Court of Calcutta vide Order Dated 11.10.2022 in connection with WPA (P) No. 292/2022 and which may endanger human life and likely to cause injury of human life. Accordingly, I apprehended the above mentioned person for violating Govt. Orders. Accordingly, I seized the above noted fire crackers under proper seizure list. The whole process of seizure was made between **23.25 hrs to 23.50 hrs** in presence of one independent witnesses. Subsequently, I arrested the above noted accused person namely Ranjan Das observing all the formalities and informing the ground of his arrest. This refers to Pradhan Nagar PS GDE No-1378 dated 25.10.2022.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person Ranjan Das(42) S/O Lt Devan Das of Baghajatin colony, P.S: Pradhanagar, Siliguri , Dist: Darjeeling under proper section of law and arrange for its investigation.
