Sirs,

With the due regard and humble submission I Kavita Kahar w/o late Ashok Kumar Kahar resident of Ry. Str. No. 235/D, Hospital colony, Near U.R.P. police station P.O + P.S. Pradhan Nagar, Dist. Darjeeling. do hereby submit the following for your kind information and necessary legal action as follows:

- ① That on 23/10/2022 at about 7 P.M. when I along with minor children <sup>was</sup> in the house suddenly ~~that~~ <sup>was</sup> there was a huge sound of crackers in front of my main gate and I show Rohit Das and Chandan Das are burning crackers just in front of main gate of my house and when I protested they became aggressive and started to abuse me in filthy languages and when I told not to use filthy languages then they told that they can do anything as it is a road and no one can stop them and fled away.
- ② That on 24/10/2022 at about 8 P.M. three persons namely Rohit Das, Kundan Das, and Chandan Das along with their associates came ~~with~~ just in front of my house and started to burst/burn huge sound crackers and when I protested they again abuse me in a very bad language and enter into my house and pulled my hairs and my cloths and they also assaulted my minor

- daughters and they received injuries upon their body and they also destroyed all goods and articles and flower which were decorated in the house.
- ③ That parbati Das and Rakha Das also came with bamboo sticks in their hand and they also assaulted me. ~~and ~~in the ~~mean time~~ at~~~~
  - ④ That in the mean time Ajit Das came and tried to outrage of my modesty and when I cried for help then Birandra Sah and his wife Ranjita Sah and other neighbour Suroja oelsi along with her husband namely Sita Ram Sah came to save us then the above named persons also assaulted them and used filthy languages towards them. And Kundan Das and his father namely Ajit Das pull the hairs of Ranjita Sah and assaulted her and pulled her Saree with criminal intention to Rape her.
  - ⑤ That the above named persons Rohit Das, Kundan Das, and Chandan Das threatened that they would Rape the daughter of Sita Ram Sah and no one can do any anything as they have good relation with the police.
  - ⑥ That they all threatened that they would burn the house if any complaint made against them.
  - ⑦ That Rohit Das took out knife from his pocket in order to kill Sita Ram Sah as because he was trying to save me
  - ⑧ That I am a Railway employee and always have to be side away from my house for my duty purpose.

That I have the video recording of the said incident / illegal act and activities of the above named persons

That the above named persons are very dangerous in nature and they sell drugs for their ill motive and they also consume drugs and can do any unnatural things to us / criminal activities against us. and they can also involve us in a fake case due to inimicity.

Under the above facts and circumstances you are requested to take legal action against above named persons who have assaulted, outrage the modesty and threatened to kill and Rape us.
