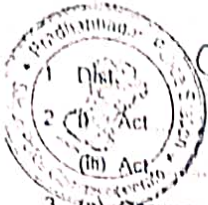

In producing herewith two accused persons namely 1. Dibakar Choudhury (46) S/O- Dilip Kumar Choudhury of Guring Busty PS Pradhan Nagar, Dist Darjeeling and 2. Shankar Choudhury (60) S/O- Late Ram deb Choudhury of Guring busty near Manasha Mandir, P.S Pradhan Nagar, Dist Darjeeling under arrest and following seized articles under seizure -:

1. 04 (Four) Packets of Jagmog Chocolate junior Cracker (each packet containing 12 pieces total $12 \times 4 = 48$ pieces).

I, SI Sibdhan Karmakar of Pradhan Nagar PS do hereby lodged a written complaint against the above mentioned accused persons namey Dibakar Choudhury (46) and Shankar Choudhury (60) to the effect that today on 25.10.2022 evening myself along with CV-128 Ajay Kumar Sahani, CV-242 Rakesh Mangar all of Pradhan Nagar PS were perfuming special mobile van duty this refers to Pradhan Nagar PS GDE No- 1410 dated 25.10.2022. During mobile van at Guring Busty Bazar, PS. Pradhan Nagar, Dist. Darjeeling found that some persons were bursting banned firecrackers by violating the Govt. rules and norms and violating the provision of law which may endanger human life and likely to cause injury of human life. On seeing Police van they fled away somehow we were managed to detain the above noted persons. On screech their pockets recovered the above noted non green firecrackers. Accordingly I seized the same in between 22.15hrs to 22.30 hrs and also prepared seizure list duly signed by the accused persons and witnesses. Accordingly I arrested them for obstructing the Govt. rules which have been promulgated by the order of Hon'ble High Court, Kolkota vide order No.11.10.2022 in c/w WPA(P) No. 292/2022.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons 1. Dibakar Choudhury (46) S/O- Dilip Kumar Choudhury of Guring Busty PS Pradhan Nagar, Dist Darjeeling and 2. Shankar Choudhury (60) S/O- Late Ram deb Choudhury of Guring busty near Manasha Mandir, P.S Pradhan Nagar, Dist Darjeeling under proper section of law and arrange for its investigation.
