Sir,

In producing herewith two accused persons namely 1. Lab Bhowmick (35) s/o Lt. Ram Bhowmick of samarnagar, Battala, near Ganga Mandir, PS Pradhan Nagar, Dist Darjeeling and 2. Raju Sha (39) S/O Kailash Sha of samarnagar, Battala, near Ganga Mandir, PS Pradhan Nagar, Dist Darjeeling under arrest and following seized articles under seizure -:

1. 02 (Two) Packets of Rahino Chocolate fire Cracker (each packet containing 10 pieces) .

I, ASI Tarun Kanti Ghosh of Pradhan Nagar PS do hereby lodged a written complaint against the above mentioned accused persons namey Lab Bhowmick (35) and Raju Sha (39) to the effect that today on 25.10.2022 evening myself along with CV-992 Jagadish Biswas, CV-646 Baban Das all of Pradhan Nagar PS were perfuming special mobile van duty this refers to Pradhan Nagar PS GDE No- 1410 dated 25.10.2022. During mobile van at Baghajatin Colony near Parvati Ghat, PS. Pradhan Nagar, Dist. Darjeeling found that some person were bursting banned firecrackers by violating the Govt. rules and norms and violating the provision of law which may endanger human life and likely to cause injury of human life. On seeing Police van they fled away somehow we were managed to detain the above noted persons. On screech their pockets recovered the above noted non green firecrackers. Accordingly I seized the same in between 22.25hrs to 22.50 hrs and also prepared seizure list duly signed by the accused persons and witnesses. Accordingly I arrested them for obstructing the Govt. rules which have been promulgated by the order of Hon'ble High Court, Kolkota vide order No.11.10.2022 in c/w WPA(P) No. 292/2022.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons 1. Lab Bhowmick (35) s/o Lt. Ram Bhowmick of samarnagar, Battala, near Ganga Mandir, PS Pradhan Nagar, Dist Darjeeling and 2. Raju Sha (39) S/O Kailash Sha of samarnagar, Battala, near Ganga Mandir, PS Pradhan Nagar, Dist Darjeeling under proper section of law and arrange for its investigation.
