Respected Sir,

With due regards, I, **SMT. MITHU SAHA**, Wife of Sri Samar Saha, Daughter of Sri Raj Kumar Das, Presently residing at Subhash Nagar Colony, Kabi Guru Sarani, Subhash Pally, Ward No. 19 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that I am the legally married wife of **SRI SAMAR SAHA**, Son of Late Amalya Kumar Saha, Resident of Rathkhola, Near Ganada Sundari Library, Ward No. 22 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, and our marriage was solemnized on 28.11.2004 and out our lawful wedlock, one male child and one female child were born their names are Rishi Saha and Rashi Saha.

Since after my marriage, my husband used to cause tremendous mental and physical torture upon me and he is a habitual drunker and after being intoxicated with huge quantity of alcohol, he used to assault me physically and as and when, I made protest, he became more furious and started to assault me mercilessly with fist and blows and even, he did not bother to assault my minor son when he tried to restrain my husband.

Sir, my husband is involved in so many criminal activities and several criminal cases are pending against him for committing theft and he was also detained in custody in a case of theft but he never tried to change his said activities and after that, he has increased his illegal activities and engaged himself in the line of gambling and misused our hardest money and as and when, he needs money, he started to commit torture upon me and my children mercilessly. Finding no other alternative, I along with my children has compelled to left the said house and took shelter at my parental house at Rabindra Nagar, Siliguri.

Thereafter, on several occasion, my husband came to my parental house with fully drunken condition and started to threaten me to give money to him as he has lost everything in the gambling and when I refused to pay the same as per his demand, he attempt to murder me and thereafter, finding no other alternative, I have lodged two written complaints before the Siliguri Women P.S. and on the basis of the said complaints, specific cases have been initiated vide Siliguri Women P.S. Case No. 90/2022, Dated: 26.05.2022, U/S - 498A/323/379/406/506 of I.P.C. R/W Sec. 3/4 of D.P. Act. After lodging the said complaints, he was arrested by the concerned P.S. and detained in Judicial Custody for few days and subsequently, released on bail. After releasing himself on bail, he became more furious and threatened to kill me but I used to avoid the same.

Sir, suddenly on the day of Ashtami i.e. on 03.10.2022, my husband again came to my house at about 11.00 P.M. and seeing me

in the road with my son, he again started to hit on my face forcefully for which, I have received blood injury and when the local people came there, he fled away from the spot and thereafter, I have visited at Siliguri District Hospital for my treatment (copy of OPD Slip of Siliguri District Hospital is enclosed herewith) but I did not make any complaint at that time.

Sir, I am the registered owner of a two wheeler scooty vehicle being Registration No. WB-74-BD-4084 (Destiny) and I have purchased the said vehicle with the financial assistance of financial authority and still now, I have been paying the monthly EMIs to the financial authority time to time and one key of the said vehicle is lying in my custody and one key is lying under the custody of my husband.

Today i.e. on 21.10.2022 at about 10.30 A.M., I have parked my said two wheeler in front of my house and entered into the room and immediately after five minutes when I again return back to the parking place, I have found that my husband unlock the said vehicle with the said key and when I tried to caught him, he fled away from the spot with my said vehicle and since then, neither he came to our locality nor he return back my said vehicle and I apprehended that he may destroy my said vehicle or use the same for his any illegal acts as he is involved in so many criminal activities and only for the purpose of his wrongful and illegal gain, he stolen away my said vehicle.


I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband as per the provision of law and recover my said vehicle and obliged thereby.
