I Sumit Gupta, the above named complainant beg to inform you that on dt. 25.10.2022 at about 00:30 hrs, when I resided near Ramghat, Naharpur along with my friend namely, Uday Roy (18) S/o Sri Harindar Roy, of Santoshi Nagar, Ramjanki Road, Ward No. 5 SMC, P.O. P.S. Siliguri, Distt - Dajeejy at that time, the above named alleged person namely Sudip Mukto restrained us and started beating us brutally with fist & blow wearing iron huckle punch and took out blade and attacked on us, we received severe injury on our persons and I treated myself at Dajeejy Distt. Hospital. ~~There~~ His intention was to snatch the mobile phone of my friend namely Uday Roy but ~~they~~ he failed to do so.

Sir, the above named alleged person is very desperate & dangerous in nature and he has threatened us for dire consequences, if I will lodge police complain.

So, please take necessary action against the said alleged person namely Sudip Mukto.
