Sir,

In producing herewith three(03) arrested accused persons namely (i) Md. Kalam (28/M) S/O Md. Islam Of Tikiapara, Matangini-II, W/No- 28, PS- Siliguri, Dist. Darjeeling,(ii) Promod Sahani(26/M), S/O- Akhil Sahani, of Hatath Colony, W/No- 28, PS- Siliguri, Dist. Darjeeling, and (iii) Biky Sahani(22/M), S/O- Lt.Kapil Sahani of Hatath Colony, W/No- 28, PS- Siliguri, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made 'Katari' measuring 24 inch (approx) including wooden butt from the possession of Md. Kalam which was kept concealed on his back side,
- (2) One iron made sword measuring 35 inch (approx) including wooden handle from the possession of Promod Sahani which was kept concealed on his back side,
- (3) One Iron rod measuring 40 inch (approx) in length from the possession of Biky Sahani which was kept on his right hand,

I, ASI- Debasish Das (37), S/O- Haripada Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md. Kalam,(ii) Promod Sahani (iii) Biky Sahani others namely Md.Ali, Md. Sherua, Md. Ansar, and Binod to the effect that today on 26.10.2022 at 00.25 hrs received a sources information that 10/12 youths have assembled at Rothkhola Ground, under Siliguri PS with a view to commit dacoity at Rabindra Nagar. The fact was diarized in GD vide Siliguri PS GDE No- 1395 dated 26.10.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Siben Sarkar, ASI Subir Sen CV/622 Ramanath Barman and CV/283 Prasenjit Dey, left for the place to work out the information. On way I contact SI Maloy Kr. Roy who was performing k-22 Van to accompany us to work out the information. We reached at Rothkhola Ground at 00.45 hrs after reaching there I met my source and as pointed by the source we started walking. At 01.00 hrs we reaching the ground and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Rabindra Nagar.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Rabindra Nagar. It is also revealed from them that Md. Ali, Md. Sherua, Md. Ansar, Binod and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md. Kalam (28/M) S/O Md. Islam Of Tikiapara, Matangini-II, W/No- 28, PS- Siliguri, Dist. Darjeeling, (ii) Promod Sahani(26/M), S/O- Akhil Sahani, of Hatath Colony, W/No- 28, PS- Siliguri, Dist. Darjeeling, and (iii) Biky Sahani(22/M), S/O- Lt.Kapil Sahani of Hatath Colony, W/No- 28, PS- Siliguri, Dist. Darjeeling (iv) Md.Ali,(v) Md. Sherua,(vi) Md. Ansar, (vii) Binod and others and arrange for its investigation.
