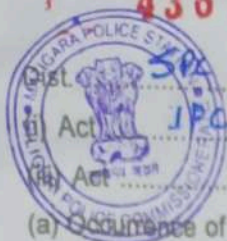

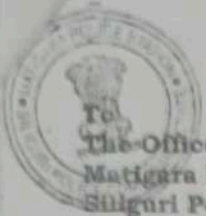

Sir,

In producing herewith one accused person Chandan Roy(25), S/O- Lalit Roy of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure -

- 1) 01(one) big packet of RHINO POWER (band sound Crackers) containing 10(ten) Pieces.
- 2) 01 (One) packet of SV King Kobra Electric Crackers (band sound crackers).
- 3) Twenty pieces of used RHINO POWER (band sound Crackers).

I, SI Uday Chakraborty of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused person namely Chandan Roy(25), S/O- Lalit Roy of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling to the effect that today on 25.10.2022 while performing night patrolling duty at Balasan Bazar area under Matigara PS, SPC found the above noted person namely Chandan Roy along with others were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise that causes disturbance of public peace and tranquility. I repeatedly asked him to stop bursting band firecrackers but he did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested him, under proper memo of arrest, informing the ground of his arrest. I also seized 01(one) big packet of RHINO POWER (band sound Crackers) containing 10(ten) Pieces and 01 (One) packet of SV King Kobra Electric Crackers (band sound crackers) from the possession of Chandan Roy and also seized twenty pieces of used RHINO POWER (band sound Crackers) from that place at Balasan Bazar.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person namely Chandan Roy(25), S/O- Lalit Roy of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
