I, NUREDA KHATUN, daughter of Md. Noor, Islam, resident of Kawakhali, P.O. Sushrutnagar, P.S. Maligara, Dist. Darjeeling would like to inform you that as follows:-

i) That MD. ASRAFUL MIYA, s/o. Sajjan Miya, resident of Masjid Para, P.O. & P.S. Bagdogra, Dist. Darjeeling, was my husband. We obtained divorce on 17.05.2022 by appearing before Muslim marriage Registrar & Kazi, at Istampur, W.B.

ii) That when our Marital Tie existed, my husband compelled my mother to give Rs. 2,80,000 to him. Moreover he misappropriated Rs. 3,00,000 from my father's Bank A/c. In the year 2019 he induced me to a Bandhan Bank A/c and obtained a loan of Rs. 1,10,000 in my name by promising that he shall pay off within one year or few months but in vain. I realised he cheated me and continued thereafter.

iii) That due to his physical and mental torture I decided to obtain divorce but even after my divorce he continued to harass me by calling me through mobile phone. He always used slang and filthy language and also threatens me to kill and rape me.

iv) That since few days my ex-husband is spreading our couple photos in facebook and Instagram which we had clicked during and before our marriage, with the intention to injure my image and also I may not able to remarry. Yesterday 24.10.2022 at about 10:50 P.M. he again called me and threatened me with dire consequences that "if I do not marry him again or engage in sexual relation with him he will kidnap and kill me."
