In producing herewith the arrested accused person namely Manoj Das (30), S/O  
Manik Das, of - Thiknikata, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling under  
arrest along with following articles viz:-

1. ASI Prembhakta Mallick of NBMC OP under Matigara P.S, SPC do hereby lodge  
this written complaint against the above noted accused person to that effect that on  
25.10.2022 at about 20.15 hrs while performing evening mobile van duty in and around  
NBMC OP Jurisdiction then I along with C/500 Mayaram Oraon & C/402 Abhishek Gupta  
reached at Thiknikata near Kawakhali Primary School and found that above noted accused  
person was bursting non green fire crackers in a negligent manner at public places and also  
violated the Hon'ble High Court. I apprehended him and on interrogation he disclose his  
name and address as Manoj Das (30), S/O Manik Das, of - Thiknikata, PO - Sushruta  
Nagar, PS - Matigara, Dist - Darjeeling. On searched (1) Seven piece Palash Chutpath, (2)  
Four piece Srikrishna Colour Plus non green fire crackers was recovered from his  
possession which I seized under proper seizure list in presence of witnesses and duly signed  
by them. I arrested him under 41 Cr.P.C after preparing memo of arrest for violating the  
Hon'ble High Court Order. The whole process of raid, seizure and arrest took place in  
between 20:25 hrs. To 20.45 hrs

I therefore pray before you that a specific case may kindly be initiated against  
arrested accused Manoj Das under proper section of law.
