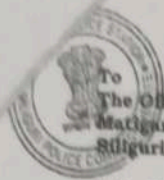

Sir,

In producing herewith two accused persons i) Rajkumar Barman(25), S/O- Dablu Barman of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling and ii) Rajkishore Barman(22), S/O- Jagadish Barman of Patharghata 03 No more PS- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure -

- 1) 18(Eighteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Rajkumar Barman .
- 2) 02 (One) packets of SV King Kobra Electric Crackers (band sound crackers) from the possession of Rajkishore Barman.
- 3) Twelve pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence.

I, SI Goutam Mallik of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned two accused persons i) Rajkumar Barman(25), S/O- Dablu Barman of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling and ii) Rajkishore Barman(22), S/O- Jagadish Barman of Patharghata 03 No more PS- Matigara, Dist- Darjeeling PS- Matigara, Dist- Darjeeling to the effect that today on 25.10.2022 while performing kalipuja patrolling duty against band fire crackers at Patharghata near Jorabridge area under Matigara PS, SPC found the above noted persons namely Rajkumar Barman and Rajkishore Barman were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise that causes disturbance of public peace and tranquility. I repeatedly asked them to stop bursting band firecrackers but they did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested him, under proper memo of arrest, informing the ground of his arrest. Accordingly, I seized 18(Eighteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Rajkumar Barman and 02 (One) packets of SV King Kobra Electric Crackers (band sound crackers) from the possession of Rajkishore Barman and also seized twelve pieces of used Chocolate bomb (band sound Crackers) found at the place at Patharghata near Jorabridge.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Rajkumar Barman(25), S/O- Dablu Barman of Paharghata, Joradighi, PS- Matigara, Dist- Darjeeling and ii) Rajkishore Barman(22), S/O- Jagadish Barman of Patharghata 03 No more PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
