In producing herewith two accused persons i) Dilip Barman(48), S/O-Sushil Barman of Balasan Pramodnagar, PS- Matigara, Dist- Darjeeling and ii) Santosh Sarkar(24), S/O- Lalmohan Sarkar of Parimalnagar, PS- Matigara, Dist- Darjeeling PS- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure -

- 1) 11(Eleven) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Dilip Barman.
- 2) 09 (Nine) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Santosh Sarkar.
- 3) 10(ten) pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence.


I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned two accused persons i) Dilip Barman(48), S/O-Sushil Barman of Balasan Pramodnagar, PS- Matigara, Dist- Darjeeling and ii) Santosh Sarkar(24), S/O- Lalmohan Sarkar of Parimalnagar, PS- Matigara, Dist- Darjeeling PS- Matigara, Dist- Darjeeling to the effect that today on 25.10.2022 while performing kalipuja patrolling duty against band fire crackers at Balasan Pramodnagar area under Matigara PS, SPC found the above noted persons namely Dilip Barman and Santosh Sarkar were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise that causes disturbance of public peace and tranquillity. I repeatedly asked them to stop bursting band firecrackers but they did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested him, under proper memo of arrest, informing the ground of his arrest. Accordingly, I seized 11(Eleven) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Dilip Barman and 09 (Nine) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Santosh Sarkar and also seized 10(ten) pieces of used Chocolate bomb (band sound Crackers) found at the place at Balasan Pramodnagar.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Dilip Barman(48), S/O-Sushil Barman of Balasan Pramodnagar, PS- Matigara, Dist- Darjeeling and ii) Santosh Sarkar(24), S/O- Lalmohan Sarkar of Parimalnagar, PS- Matigara, Dist- Darjeeling PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.


