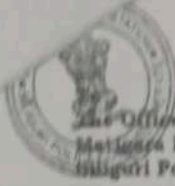

Sir,

In producing herewith two accused i) Subrata Sarkar(24), S/O- Jiwan Sarkar of Fatapukur Payachuri, PS- Rajgunj, Dist- Jalpaiguri, A/P-Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Ranjan Barman(24), S/O- Lt. Dhiren Barman of Matigara Bhangapool, PS- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure -

- 1) 13(Thirteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Subrata Sarkar.
- 2) 07 (Seven) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Ranjan Barman.
- 3) 09(Nine) pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence.

I, SI Uday Chakraborty of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned two accused persons i) Subrata Sarkar(24), S/O- Jiwan Sarkar of Fatapukur Payachuri, PS- Rajgunj, Dist- Jalpaiguri, A/P-Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Ranjan Barman(24), S/O- Lt. Dhiren Barman of Matigara Bhangapool, PS- Matigara, Dist- Darjeeling to the effect that today on 25.10.2022 while performing kalipuja patrolling duty against band fire crackers at Balasan Pramodnagar area under Matigara PS, SPC found the above noted persons namely Subrata Sarkar and Ranjan Barman were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise that causes disturbance of public peace and tranquillity. I repeatedly asked them to stop bursting band firecrackers but they did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested him, under proper memo of arrest, informing the ground of his arrest. Accordingly, I seized 13(Thirteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Subrata Sarkar and 07 (Seven) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Ranjan Barman and also seized 09(Nine) pieces of used Chocolate bomb (band sound Crackers) found at the place at Balasan Pramodnagar.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Subrata Sarkar(24), S/O- Jiwan Sarkar of Fatapukur Payachuri, PS- Rajgunj, Dist- Jalpaiguri, A/P-Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Ranjan Barman(24), S/O- Lt. Dhiren Barman of Matigara Bhangapool, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
