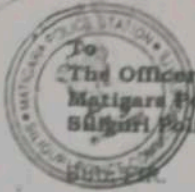

In producing herewith two accused persons namely i) Harimaha Barman(19), S/O- Gopal Barman of Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Parimal Das(23), S/O-Mangal Das of Parimalnagar, Matigara, PS- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure -

- 1) 15(Fifteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Harimaha Barman.
- 2) 09 (Nine) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Parimal Das
- 3) 07(Seven) pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence.


I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned two accused persons i) Harimaha Barman(19), S/O- Gopal Barman of Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Parimal Das(23), S/O-Mangal Das of Parimalnagar, Matigara, PS- Matigara, Dist- Darjeeling to the effect that today on 26.10.2022 while performing kalipuja patrolling duty against band fire crackers at Potiramjote, Tirangamore area under Matigara PS, SPC found the above noted persons namely Harimaha Barman and Parimal Das were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise that causes disturbance of public peace and tranquillity. I repeatedly asked them to stop bursting band firecrackers but they did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested him, under proper memo of arrest, informing the ground of his arrest. Accordingly, I seized 15(Fifteen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Harimaha Barman and 09 (Nine) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Parimal Das and also seized 07(Seven) pieces of used Chocolate bomb (band sound Crackers) found at the place at Potiramjote, Tirangamore.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Harimaha Barman(19), S/O- Gopal Barman of Parimalnagar, PS- Matigara, Dist- Darjeeling and ii) Parimal Das(23), S/O-Mangal Das of Parimalnagar, Matigara, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.


