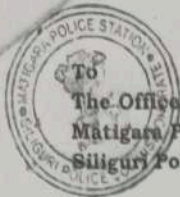

Sir,

In producing herewith following articles under proper seizure. i.e.

- 1] 50(Fifty) Cartons of "IMPERIAL BLUE" Superior Grain Whisky each carton contains 24(twenty four) sealed bottles of "IMPERIAL BLUE" Superior Grain Whisky, each bottle contains 375ML, Value Rs. 120/- each bottle (total 50X24=1200X 375ML= 450 Litres, total value Rs. 120X1200=Rs.144000/-) found inside one utility vehicle having registration No.WB-73F-1965 (Bolero Pick-up) and marked as 'Exhibit-A'. Out of which one sealed bottle was taken as sample for examination and marked as 'Exhibit-A1'.
- 2] 09(Nine) Cartons of "IMPERIAL BLUE" Superior Grain Whisky, each carton contains 48(Forty Eight) sealed bottles of "IMPERIAL BLUE" Superior Grain Whisky, each Bottle contains 180ML, Value Rs. 60/- each bottle (total 09X48=432X180ML= 77.76 Litres, total value Rs. 60X432=Rs.25920/-) found inside one utility vehicle having registration No. WB-73F-1965(Bolero Pick-up) and marked as Exhibit-B. Out of which one sealed bottle was taken as sample for examination and marked as 'Exhibit-B1'.
- 3] One utility vehicle having registration No. WB-73F-1965(Bolero Pick-up) inside which Exhibit-A & Exhibit-B has been found.

I, PSI Shekhar Adhikary presently posted at Matigara Police Station; Siliguri Police Commissionerate would like to lodge this written complaint against the owner and driver of the vehicle having registration no. WB-73F-1965(Bolero Pick-up) to the effect that today on 26.10.2022 at 14.15hrs I received a specific source input that a utility vehicle (Bolero Pick-up) loaded with illegal liquor was coming towards Matigara through Tumbajote. The matter was diarized vide Matigara PS GDE No. 1357, dated-26.10.2022. Accordingly, I informed the matter to the Officer-in-Charge, Matigara Police Station. Subsequently, as per his kind direction myself along with ASI Tapan Das, Const.-974 Mintu Sen, Const.-1053 Paresh Rava, Const.- 219 Sonatan Chitrakar, Const.- 1035 Santosh Rabidas, CV-155 Sukumar Das, CV-387 Sukumar Barman all of Matigara PS left for Matigara Tumbajote by govt. vehicle to verify the veracity of the information. This refers Matigara PS GDE No.1358, dt. 26.10.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On reaching at Matigara Tumbajote I contacted with my source and subsequently being pointed my source I found a loaded utility vehicle having registration no. WB-73F-1965(Bolero Pick-up) at Tumbajote near Petrol pump into a narrow lane in abandoned condition. Accordingly I searched for the owner/driver of the said vehicle but found no one. Subsequently, I contacted with local people and came to know that few minutes ago driver of the vehicle placed the vehicle at this place and runaway. Then I searched the vehicle in presence of available local witness and found that the said vehicle was loaded with Carton boxes of liquor("IMPERIAL BLUE" Superior Grain Whisky). Then I counted all Carton boxes of liquor and found total 50(Fifty) Cartons of "IMPERIAL BLUE" Superior Grain Whisky each carton contains 24(twenty four) sealed bottles of "IMPERIAL BLUE" Superior Grain Whisky, each bottle contains 375ML, Value Rs. 120/-each bottle (total 50X24=1200X 375ML= 450Liters, total value Rs. 120X1200=Rs.144000/-) and 09(Nine) Cartons of "IMPERIAL BLUE" Superior Grain Whisky, each carton contains 48(Forty Eight) sealed bottles of "IMPERIAL BLUE" Superior Grain Whisky, each bottle contains 180ML, Value Rs. 60/-each bottle (total 09X48=432X180ML= 77.76 Litres, total value Rs. 60X432=Rs.25920/-) found inside the said utility vehicle having registration No.WB-73F-1965(Bolero Pick-up). Subsequently I searched the vehicle properly but found no valid documents in support of the liquor found inside the vehicle having registration No.WB-73F-1965(Bolero Pick-up). I also wait sometimes for the owner/driver/claimant of the vehicle having registration No.WB-73F-1965(Bolero Pick-up) but in vain. Accordingly I seized all the liquor as noted above in presence of available local witness namely i) Md. Azad(40), S/O- Md. Mehebab and ii) Ratan Barman(40), S/O- Ramoni Kanta Barman both of Tumbajote, Beldangi, PO+PS- Matigara, Dist-Darjeeling following all formalities. The whole process of seizure has been made in between 15.15 hrs to 16:55 hrs.

From the above noted circumstances It is evident that the owner/ driver of the vehicle having registration No. WB-73F-1965(Bolero Pick-up) is involved in carrying and dealing in illegal liquor for his/ their wrongful gain.

Therefore, I pray before your good self that a specific case against the the owner/ driver of the vehicle having registration No. WB-73F-1965(Bolero Pick-up) may kindly be initiated under proper section of law and may cause for its-investigation.
