In producing herewith 01 (one) arrested accused person namely (1) Bapi Das 42yrs, S/O Ranjit Das of NJP near Bibadi Sangha Club Ward No- 35, PS- NJP, Dist- Jalpaiguri under arrest..

I ASI Biswajit Saha of Panitanki Town Out Post , under Siliguri PS , SPC would like to lodge a written complaint against the above noted 01 (one) arrested accused person to the effect that on 26.10.22 at about 21.25 hrs while performing evening mobile van duty, I received information from my reliable source that above noted accused person along 2/3 unknown persons are enjoying Diwali Celebration with lighting, using and bursting illegal non green fire-crackers at Hakimpara Raja Ram Mohan Roy road under Siliguri PS/SPC, violating the provision of law, which may endanger to human life, likely to cause injury and may cause loss of public property of the area. This refers to Panitanki TOP GDE No-541 Date-26.10.2022. Accordingly, I informed the Matter to O/C Panitanki TOP. As per his direction, I along with force C/114 Naresh Hasda, and CV/1009 Manoj Thakur rush to the spot to work out the veracity of information. On reaching at Hakimpara Raja Ram Mohan Roy road under Siliguri PS/SPC, I Contacted with my source and as shown by, I red hand apprehended the above noted accused person others 2/3 unknown managed to fled away from the spot which are celebrating the Diwali festival with lighting and using non green illegal Fire Crackers, if any accident took place due to negligent act of the accused persons that may cause loss of life and property of the area. The Govt. band Fire- Crackers were any precautionary and safety measure. On search the following band Non green fire crackers was recovered from the possession of accused Bapi Das which was he along with others 2/3 bursting in public place. Accordingly, I seized the same under proper seizure list and arrested the above noted accused persons U/S 41 Cr.PC.

Under the above fact and circumstances, I pray before your kind honor to start a specific case against accused person namely Bapi Das 42yrs, s/o Ranjit Das of NJP near Bibadi Sangha Club Ward No- 35, PS- NJP, Dist- Jalpaiguri along with unknown 2/3 others under proper section of law and arrange for its investigation.
