Respected Sir,

I **Smt. Arundhati Kundu**, Wife of **Bachhu Das**, Resident of matangani Hazra Sarani, Rathkhola, Near Nabin Sangha Club, P.O. & P.S. Siliguri, District - Darjeeling, (W.B.). Pin - 734006, do hereby like to inform you as follows :-

1. That I am the owner of one restaurant namely "Rannaghar" situated at Raja Ram Mohan Roy Road, Ward No. 15 of S.M.C. P.O. - Siliguri, P.S. - Panitanki Out Post (Under Siliguri Police Station), District - Darjeeling and I am running the said business since last 2 years with good gesture and well reputation.

2. That on 26.10.2022 at about 1.45 A.M. when me and my husband went out of the restaurant for delivery of food and in the cash counter one of my friend namely **Mohan Karmakar** was present along with other staffs. Suddenly one person 1. **Gautam Das**, Son of Not Known, Resident of Raja Ram Mohan Roy Road, Near Kamakhya Sweets, Siliguri, came to my restaurant and started to call some antisocial persons over his telephone. After some time some other antisocial persons namely 2. **Biswanath Saha**, Son of Not Known, 3. **Dipak Palit**, Not known, along with some other 2 to 3 persons suddenly came to my restaurant and without any realm and reason attacked my friend **Mohan Karmakar** and started to beat him mercilessly with fist and blows and also started to destroy the articles and decorations in the room. At that time other staffs tried to resist them but they failed as the above named persons were very much furious in nature.

3. That at that time me and my husband returned to my restaurant and saw that the above named accused persons are desperately beating my friend **Mohan Karmakar** and also destroying all the articles and decorations of our restaurant and creating a great chaos there. At that time me and my husband rushed towards them and tried to resist them from doing their illegal acts. At that time they also attacked me and my husband and one of them namely **Dipak Palit**, started to pull my hair and cloths and also hit me in the chest, left ear and back furiously and also try to outrage my modesty. At this when I tried to resist him he suddenly snatched my

gold chain of approx 1.5 Bhari from my neck and pushed my forcefully. At that time my husband also tried to resist them but the above named persons also attacked my husband and beat him mercilessly with fist and blows and also hit him in his head, chest and pushed him forcefully and also snatched one gold chain from his neck approx 2 Bhari. Moreover the above named antisocial persons also beat other staffs of my restaurant. The above named persons also steal a cash amount of Rs. 20,000/- (Rupees Twenty Thousand Only), from my cash counter.

4. That the above named accused persons also threatened us that they will put kerosin oil in our restaurant and set fire. Moreover they also threatened us that they are above the Law and if we try to take any legal action against them then they will kill us and destroy our restaurant and will defame us and destroy my reputation. Subsequently hearing our chaos some local persons came and rescued us from the above named persons and when the local people started to gather the above named persons fled away.

5. Subsequently some people came and rescue me, my husband and other staffs from him and gave us necessary medical assistance.

Therefore under the above mentioned circumstances I request before your good self to kindly look into the matter and take necessary action against the aforesaid persons as per the provision of law, otherwise my legal rights will be in jeopardy and for this act of kindness I shall remain extremely grateful to you.
