P.O. Sevoke Road, P.S. Bhaktinagar, Dist-Jalpaiguri, Pin-734001 in
the state of West Bengal, would like to lodge this Written Complaint
against my brother in-law namely Papon Das, S/o Late. Debendra Das
and his wife Sathi Das Debnath @ Lakkhi, Wife of Sri Papon Das,
resident of resident of Janata Nagar, Ward No. 44, S.M.C., P.O. Sevoke
Road, P.S. Bhaktinagar, Dist-Jalpaiguri, Pin-734001. That since last
few years, the above mentioned persons are continuously harassing
me and there is always hot altercation goes on regular basis due to
our property partition matters and the wife of the above mentioned
person always uses abusive and filthy language upon me and my
entire family. That the above mentioned Papon Das also uses very
vulgar and abusive language upon me and commits the outrage of a
female's modesty in the society by using or spreading abusive
comments upon my character. That the person above named always
threatens me that he will kill me and my minor son whenever he will
get the opportunity as I along with my minor son stay alone when my
husband goes out of station for his business purpose. That on
22.10.2022, the wife of the above mentioned person was making hue
and cry by herself and she threatened me that she will implicate my
husband in a false Rape case and thereby she will acquire the entire
property and thereafter she called the Police and the Police came to
my house and visited and interrogated the matter and

finding no material for case the Police left our house. That, today i.e. on 24.10.2022 at about 01:00 PM the above mentioned persons accompanying some other local persons namely Smt. Sunanta Saha, W/o praraj Saha and Smt. Piyali Das, W/o Kartik Das all are residents of the above mentioned address forcefully entered into my room and assaulted me badly with fists and blows and Papon Das and his wife taken away cash of Rs. 9600/- from my husband's Wallet which was kept on the Dinning Table and they further threatened us to transfer the entire property in the favor of the above mentioned Papon Das otherwise they will kill us at night.
