Sir,

In producing herewith one arrested accused person namely Raju Choudhary -24yrs S/O- Rajkumar Chowdhury of Salugara Dimdima busty PS Bhaktinagar, Dist-Jalpaiguri along with following seized articles viz:

1. Eleven (11) packets of Navarang super fire crackers each packet contained with 03 pieces total  $11 \times 3 = 33$  pieces.
2. Eight (08) packet of Green Shower Crackling fire crackers each box contained with 03 pieces total  $08 \times 3 = 24$  pieces
3. Two(02) boxes of Golden light Super fire crackers each box contained with 10 pieces total  $02 \times 10 = 20$  pieces
4. Four (04) Boxes of Anar Big fire crackers each box contained with 10 pieces total  $04 \times 10 = 40$  pieces
5. Three (03) packets of Jio Generator Anar fire crackers each packet contained with 03 pieces total  $03 \times 03 = 09$  pieces
6. Four (4) boxes of whistling wheel fire crackers each boxes contained with 5 pieces total  $04 \times 5 = 20$  pieces
7. Thirty four (34) packets of King cobra electric crackers each packet contained with 28 pieces total  $34 \times 28 = 952$  pieces
8. Two (2) packets of Rhino power chocolate fire crackers each packet contained with 10 pieces total  $02 \times 10 = 20$  pieces
9. One(1) packets of puja Jumbo fire crackers each packet contained with 10 pieces

I beg to report that I, SI Rantu Haldar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 25.10.22 at 20.15hrs received secret source information that one person stored and selling huge quantity of fire crackers at his Grocery shop at Salugara Bazar. Diarized the information in GD vide Bhaktinagar PS GDE no-1213 dated 25.10.22 and as per your kind instruction myself along with, Const/1431 Dilip Barman, CVF/014 Labonyamoy Barman, left for Salugara Bazar to work out the information.

At about 20.45 hrs we reached at Salugara Bazar, sometimes after, being identified by the source our police party held raid in the shop of Raju Choudhary and recovered the above noted articles from his shop. On demand he could not produce any valid documents/license in support of said fire crackers and also stated that he was selling the band fire crackers in his shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by them and accused person from the possession of Salugara Bazar and arrested him u/s 41 Cr.pc. (The seizure was made in between 20.55hrs to 21.35hrs)

I therefore request you a specific case may kindly be started against the accused person namely Raju Choudhary -24yrs S/O- Rajkumar Chowdhury of Salugara Dimdima busty PS Bhaktinagar, Dist-Jalpaiguri under proper section of law and arrange for its investigation.
