DH-6/2, Action Area 1D, New Town, P.S - New Town (old Rajahat), Kolkata - 700160, New Town (old Rajahat), P.O - Rajahat and its Corporate office at Grape Garden, NO 27 3rd A Cross 18th Main 6th Block, Koramangala Bangalore - 560095, P.O - Koramangala & P.S - Koramangala, do hereby intimate you as follows :-

That one of our branch offices namely Ujjivam Small Finance Bank Ltd, Siliguri BS is situated and located at Ujjivam Small Finance Bank, Kelsen Complex, Serake Road, Beside - City Garden, Dt - Darjeeling, Pin - 734001 and is commonly known as Siliguri BS.

That I Mr. Sukumar Roy (CRO - UJJ21077) visited 65 no. center at Telipera, Majhabari today morning. As ~~he~~ I entered into the area, the husband of one IOD customer (Maliti Barman - CIF: 3511002352) name - Pradip Barman forcibly detained in along with customer's son as CRO visited that house for IOD collection of customer, after visiting customer's house his husband ~~forcibly~~ forcefully bought him outside of house and beat him with his son. And also broken my phone.

In light of the given circumstances request you to take necessary legal action as permitted under due process of law.
