Sir,

With due respect, I am producing herewith one arrested accused person namely Ashiq Oraon @ Ashish-28yrs s/o Lt Madan Oraon of Gowala busty, Near Green Vally, ward no-43, PS Bhaktinagar Dist Jalpaiguri with connected documents.

I ASI Dipak Karmakar of Bhaktinagar P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on 26-10-2022 at evening receive source information that some persons had been using fire crackers/fireworks Bhanunagar Road near Sai Hospital under Bhaktinagar PS. This refers to Bhaktinagar PS GDE No-1280 dated 26.10.22 .Accordingly I informed the information to I/C Bhaktinagar PS and as per order by I/C Bhaktinagar P.S myself along with force conducted raid against used fire crackers/fire works at Bhanunagar Road near Sai Hospital under Bhaktinagar PS as there was secret source information that they had been used fire crackers/fire works of beyond permissible sound limit illegally. During raid we saw the above noted person had been using fire crackers/fire works at Bhanunagar Road near Sai Hospital, on been seeing police party he tried to flee away from the spot but anyhow we apprehended the above noted person who on being asked identified himself as Ashiq Oraon @ Ashish-28yrs s/o Lt Madan Oraon of Gowala busty, Near Green Vally, ward no-43, PS Bhaktinagar Dist Jalpaiguri also seized Two packets of Burima chocolate fire crackers. Accordingly I seized the same in presence of witness duly signed by them.

On being asked the above noted person admitted his guilt of purchasing, storing and used of fire crackers at Bhanunagar Road near Sai Hospital without license. He also could not produce any documents in respect of those fire crackers and also he used fire crackers/ fireworks and stored without any precautionary and safety measure at Bhanunagar Road near Sai Hospital. The said stored fire crackers are combustibile in nature and endanger to human life and property. On being asked, the above noted person stated before me that, he was well aware the order of honorable high court Calcutta that not increases the air pollution by using the fireworks. Accordingly, I arrested the above noted one accused person with the help of other force u/s- 41 Cr.P.C after maintaining all rules and formalities in presence of available witnesses and acknowledge to the accused person.

Hence, I pray before you that a specific case may kindly be started against the above noted person namely Ashiq Oraon @ Ashish-28yrs s/o Lt Madan Oraon of Gowala busty, Near Green Vally, ward no-43, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
