
I, Smt. Sumitra Devi, wife of Sri Laxman Prasad Gupta, resident of Kadamtala, Champasari, Post Office Champasari, Police Station Pradhan Nagar, District Darjeeling would like to inform you that on 28/09/2022 at about 10.20 P.M when my husband was standing at Kadamtala, one motor cycle being registration no. WB 74 BJ 3266 proceed from Champasari More to Debidanga with very high speed rashly and negligently dashed my husband. As a result my husband sustained gravious injuries all over the body including his right leg fractured and sustained head injury. He was admitted to Pulse Hospital with very critical condition. He was admitted there about 22 days with very critical condition and still now he cannot talk to anyone. I cannot lodge the complaint within time as we were busy to look after him.

Under the above circumstances I would like to request you to please take necessary legal step against the rider of the motor cycle bearing registration no. WB 74 BJ 3266 as per provisions of law.
