Sir,

With due respect and humble submission, in producing herewith two accused namely (1) Mithun Kumar (23) S/O Dani Thakur of Raja Pakar, Ward No.10, P.S- Raja Pakhar, Dist. Vaisali, Bihar & (2) Suim Sarkar (24) S/O Swapan Sarkar of Bamon Para, P.S- Kotwali, Dist. Jalpaiguri (not verify) under arrest along with following articles under proper seizure ;

- i) 12(Twelve) bottles of ROYAL STAG, Deluxe Whisky, Blended and Bottled by Aroma India (P) Ltd, Brahmaputra Industrial Park, Plot No.59-60B, Village Sila, North Gowahati, Kamrup, Assam, each containing 750 ML, each MRP 480/-
- ii) 07(Seven) Bottles of ROYAL CASTLE, Blue Premium, Whisky Blended and bottle by Mount Distilleries Ltd. Mazitar Rangpo, Sikkim, each containing 750 ML, each MRP 250/-
- iii) 02(Two) Nylon Hand bags.

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused persons to the effect that today on 28.10.22 in course spl mobile van duty at PS area with force CV/128 Ajay Kr Sahani, CV/223 Swapan Chhetri vide PDN PS GDE NO 1578 dtd.28.10.22. During mobile duty I received an information that the two persons were selling liquor illegally at Siliguri Junction, near Raj Bus Counter under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted persons and search their bags and recovered above noted articles, On demand apprehended persons failed to produce any valid document in respect of recovered articles. On interrogation they admitted that selling the same illegally without obtaining valid document for their illegal gain. Accordingly, I seized & label the above noted articles in between 21.45 hrs to 22.25 hrs. All the seized liquor are Sikkim & Assam made liquor. Following which West Bengal Government revenue has been lost. and I arrested them.

Therefore, I request you to start a specific case under proper section of law against the arrested persons namely 1) Mithun Kumar (23) S/O Dani Thakur of Raja Pakar, Ward No.10, P.S- Raja Pakhar, Dist. Vaisali, Bihar & (2) Suim Sarkar (24) S/O Swapan Sarkar of Bamon Para, P.S- Kotwali, Dist. Jalpaiguri and arrange for its investigation.
