I, SI Binup Mahato, of Bagdogra PS do hereby producing arrested one accused person namely Sanjay Thakur (34) s/o Ram Bilash Thakur Pramod Nagar PS Bagdogra Dist. Darjeeling along with the following seized Fire crackers under proper seizure list viz;

- (1) One Packet containing 08 (eight) Nos Samim's RHINO POWER CHOCOLATE FIRE Crackers, S.S. Enterprise, Kolkata (INDIA) .

I SI Binup Mahato of Bagdogra PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that today on 25 10.22 at 14-05 hrs myself alongwith ASI Khagen Barman C/1008 Kanak Roy, CV- 389 Janak Singr, VP-01 Ansalam Kujur, VP-02 Pradij Roy were performed Spl. Evening mobile duty in c/w Kalipuja festival and also prevent to sale and bursting of firecrackers for strict implementation of order of the Hon'ble High Court, Calcutta vide Bagdogra PS GDE No. 1113 dt. 25.10.22 . At 16-45 hrs while myself alongwith force arrived near Panighata More and found that one person has been bursting of firecrackers at Panighata More in front of his shop under PS Bagdogra violating the provision of law and also direction, issued by the Hon'ble High Court, Calcutta which may endanger human life and likely to cause injury, accordingly I share the information to the duty officer and also O.C. Bagdogra PS and as per his instruction we apprehended the above noted one person in presence of witnesses namely (1) Indal Thakur (25) s/o dinesh Thakur of Kestopur PS- Bagdogra Dist. Darjeeling and (2) Galu Thakur (22) s/o Siyasina Thakur of Putimari PS- Bagdogra, Darjeeling and on being searched I recovered above noted fire-crackers from his possession as he was violating of the directives of the Hon'ble Court regarding bursting of non-permitted fire crackers which are combustibile in nature and endanger to human life and property. Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused person and labeled the same in presence of witnesses. As such I arrested the above noted one accused person and issued memo of arrest on the spot duly sign by him. The seizure & arrest was made in between 17-05 hrs and 17-45 hrs

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused persons namely Sanjay Thakur (34) s/o Ram Bilash Thakur Pramod Nagar PS Bagdogra Dist. Darjeeling under proper section of Law, to arrange for its investigation.
