I Shaily Das Dey, wife of Goutam Das, residence  
of Geeta Bhawan, Raja Ram Mohan Roy Road, Hakimpara  
Siliguri, would like to bring to your notice that  
yesterday night at around 11:30 - 12:00 pm my daughter  
Dipti Das along with her friend Tashashree Dey called  
me from Rannaghar situated near Karmakhya Mishram  
Bhandar, Raja Ram Mohan Roy Road, Hakimpara, Tripura  
that for only some amount the shop keeper was  
not allowing them to come back home. Though I,  
myself with one of my friend took them to that  
shop for dinner and paid the money in advance  
whatsoever they charged / told me After receiving  
the phone from my daughter I again went there  
to look at the matter but instead of communicating  
well Mr. Mohan Karmakar along with Anandhuti  
started misbehaving and offensive languages.

even out of the CCTV surveillance they started pushing us. Not being able to co-opt with the situation, we came back and inform the other residence including my husband after which some of the went there to solve the matter but a person ~~was~~ named Bachhu started pushing, pulling and other offensive behaviour with them. gradually the matter went out of control.
