III ) That sir they all accused person are very much criminal in nature they also snatched my are golden chain and what ever they have found golden article from my house.

IV) That sir their all activities are immoral, illegal in our locality they have told me that they are belongs from shiva gang and no body will do any thing against them.

V) That Sir they flew away from my house and threatened me that not to go any police otherwise they will sure kill me along with my family member so how can I along with my family members live at my house now I am passing my days in very difficulties.
