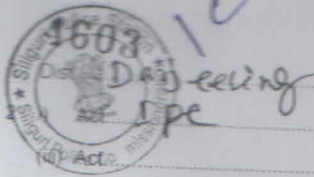

Sir,

With due respect I Sri Praveen Kumar Agarwal, S/o Sri Gangadhar Agarwal, resident of S.P. Mukerjee Road, Khalpara, P.O & P.S- Siliguri, District – Darjeeling the Director Siddhi Vinayak Exim Pvt . Ltd having it office at Hill Cart Road, Bata Gali , P.O & P.S – Siliguri, District – Darjeeling which deals with the cloth materials and we have one godown situated at Anjani Apartment, near shop factory, Ganganagar, Siliguri, Darjeeling. Since last some time I am noticing about the shortage of stock in my godown as per our statements of account. On enquiry I came to know that our staff namely Mahesh Sharma S/o Pawan Sharma resident of Narayan Niwas M.G Road Khalpara Siliguri in collusion with our cycle venpullor namely Manoj Paswan S/o Ramdeo Paswan, resident of Adarsh nagar, Near Saw Mill, Siliguri Darjeeling having his permanent address at Deoria Purani Bazar, Deoria, Muzzafarpur, Bihar alongwith one another staff namely Nayan Das S/o Mitthu Das, resident of Bhalobasamore, P.S – NJP, District – Jalpaiguri used to commit theft in my godown. On enquiry with the said Venpullor Sri Manoj Paswan, he disclosed that the said Mahesh Sharma and Nayan Das used to ask him to load cloth material to supply the same to the customers and he used to drop the bundulls of cloth materials as per guidance of the said Mahesh Sharama and Nayan Das since the month of April 2022 and upon detailed enquiry he took me to one Rajesh Enterprise represented by its proprietor Sri Rajesh Agarwal, having its business place at Mahabirsthan, Bata Gali, Siliguri. On enquiry the said Rajesh Agarwal admitted that he used to purchase the cloth materials from Mahesh Sharam and Nayan Das in a very low cost. Upon enquiry the said Mahesh Sharma and Nayan Das admitted their guilt that since the month of April 2022 they are thieving the cloth materials from the godown and selling the same to Rajesh Enterprise along with several other business firms including outside of West Bengal.

After calculation of stock, I found that there is the shortage of huge quantity of cloth materials and mosquito net which amounts to Rs. 20,00,000/- and the said Mahesh Sharama, Nayan Das and Manoj Sahani with common intention have thieved the cloth materials from our godown and sold in the open market for their illegal gain and wrongful loss to me. Sir I am in reasonable belief that the said Mahesh Sharma, Nayan Das and Manoj Sahani will be able to recover my cloth materials from several other the persons to whom they have sold after thieving the same from my godown.

Be it mention here that on 23 - 10 - 2022 the said Mahesh Sharma came to me and handed over his Mobile Phone alongwith its SIM Card and Memory Card, Bank Pass Book and ATM Card to show his innocence but after handing over the same, he fled away to avoid any further enquiry and till to date the said Mahesh Sharma and Nayan Das and Manoj Sahani is not traceable.

So requesting you to investigate the matter and take necessary legal action against the above named persons and recover the thifted cloth material and for that I will highly oblige to you.
