That as per Ld. Court Order today I went to see my son and I have also intimated this to police. Now when I went in my husband place my husband and in-laws didn't allow me to look after my son. From very distance I saw my son crying. My husband and in laws assault me badly also hamper my prestige, honour and dignity and used all foul and slang languages of my family members which cannot be tolerated. I requested several times but my request are all in vain.
