

In producing herewith the 09 (Nine) accused persons namely (1) Manaranjan Das (22) S/O Arun Das of Niranjnagar Ghogomali w/no. 36 PS Bhaktinagar Jalpaiguri (2) Pravat Das (25) S/O Gopal Das of do (3) Sanju Das (18) S/O Hari Das of do (4) Bindu Das (30) S/O Sushil Das of do (5) Gopal Mandal (26) S/O Gakul Mandal of do (6) Niranjnagar Das (31) S/O Arun Das of do (7) Banchar Das (46) S/O Late Neru Das of do (8) Bappa Barman @ Gouranga (21) S/O Bhakta Barman of do and (9) Sanjay Das (21) S/O Dutiram Das of Purba Hatiadanga PS Bhaktinagar Jalpaiguri along with the following seized articles with seizure list;

- (4) 10 numbers of empty Beer`a bottles


I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar PS lodged a written complaint against the above noted accused persons to the effect that on 27.10.2022 at 22.20 hrs received information that a gambling was going on inside the Tin shed house of Banchar Das (46) S/O Late Neru Das of Niranjnagar Ghogomali w/no. 36 PS Bhaktinagar Jalpaiguri . Accordingly I diarized the matter vide ASG OP G.D.E. No. 769 dtd. 27.10.22 & informed the matter to O.C Ashighar OP and as per his kind direction, myself along with , ASI Inzamamul Hoque, ASI Amit Mallick, Const 1181 Bhubesh Ch Roy, Const- 376 Shymal Choudhury CV- 307 Ful Kumar Roy all are of Ashighar OP left for the spot to verify the veracity of information vide ASG OP G.D.E.No. 770 dt- 27.10.2022 On arrived at 22.45 hrs at the spot found that the above noted accused persons and others are playing gambling with the help of playing card to each other by cash to wrongful gain and wrongful loss and on seeing the police party they try to flee away from the spot but on hot chased police party apprehended the above noted accused persons namely (1) Manaranjan Das (22) S/O Arun Das of Niranjnagar Ghogomali w/no. 36 PS Bhaktinagar Jalpaiguri (2) Pravat Das (25) S/O Gopal Das of do (3) Sanju Das (18) S/O Hari Das of do (4) Bindu Das (30) S/O Sushil Das of do (5) Gopal Mandal (26) S/O Gakul Mandal of do (6) Niranjnagar Das (31) S/O Arun Das of do (7) Banchar Das (46) S/O Late Neru Das of do (8) Bappa Barman @ Gouranga (21) S/O Bhakta Barman of do and (9) Sanjay Das (21) S/O Dutiram Das of Purba Hatiadanga PS Bhaktinagar Jalpaiguri . On being searched at the spot (1) Cash Rs. 5640 /- as Board money. (2) 03 packets of playing cards (3) 05 pices of used candels (4) 10 numbers of empty Beer`a bottles are found lying there . Accordingly I seized all the above noted articles in presence of two independent witnesses namely (1) Sujit Roy (31) S/O Late Satish Roy of Ashighar Colony PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjnagar W/no.36 PS Bhaktinager Dist. Jalpaiguri under proper seizure list with a view to take legal action as they violated the prohibition U/S- 3/ 4 of W.B.G & P.C Act.

In this circumstances it is clear that the above noted accused persons namely (1) Manaranjan Das (22) S/O Arun Das of Niranjnagar Ghogomali w/no. 36 PS Bhaktinagar Jalpaiguri (2) Pravat Das (25) S/O Gopal Das of do (3) Sanju Das (18) S/O Hari Das of do (4) Bindu Das (30) S/O Sushil Das of do (5) Gopal Mandal (26) S/O Gakul Mandal of do (6) Niranjnagar Das (31) S/O Arun Das of do (7) Banchar Das (46) S/O Late Neru Das of do (8) Bappa Barman @ Gouranga (21) S/O Bhakta Barman of do and (9) Sanjay Das (21) S/O Dutiram Das of Purba Hatiadanga PS Bhaktinagar Jalpaiguri violated sec - 3/4 of W.B G & P.C Act-1957. Accordingly I arrested them as they are violating the above mentioned section of the Acts.

Hence I pray to you that one specific case may kindly be started against the above noted accused persons and to arrange for its investigation.
