2. 04 (Four) bottles of STERLING Reserve whisky each bottle containing 180 ML

3. 04 (Four) bottles of IMPERIAL BLUE classic Grain whisky each bottle containing 180 ML which was kept in one big nylon bag.

I, SI Rantu Halder of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 27.10.22 at about 21.30 hrs received a source information that the above noted accused person has possessed huge amount of liquor in his grocery shop at Gandhinagar, Monpuri busty under Bhaktinagar PS for selling the same to local customers. This refers to Bhaktinagar PS GDE No. 1335 Date. 27.10.22. Accordingly the information shared I/C Bhaktinagar PS and as per your kind direction I along with C/ 1431 Dilip Barman, CVF/614 Sumit Kr. Roy, CVF/935 Bipllab Roy, CVF/619 Dharmendra Roy of Bhaktinagar PS left PS to work out the information. At about 21.45hrs we reached at Gandhinagar, Monpuri busty and as shown and being identified by the source held raid at the aforesaid shop and apprehend one person who disclosed his name and address as noted above. Further maintaining his decency and observing all formalities searched inside the house and recovered huge amount of above noted seized liquor. On demand of license and documents in respect of possessing the liquor he failed to produce the same. On enquiry the apprehended accused person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 22.10 hrs to 22.45 hrs as he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.
